7 Be it resolved by the Senate, the House of Representatives concurring:

8 Section 1. The 1997 General Assembly, Regular Session 1998, may consider

19 Section 4. The 1997 General Assembly, Regular Session 1998, may consider
20 "A JOINT RESOLUTION HONORING THE LIFE AND MEMORY OF

1 ARCHIBALD KIMBROUGH DAVIS, FORMER MEMBER OF THE GENERAL
