A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE VARIOUS
SPECIAL REGISTRATION PLATES.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-63(b) reads as rewritten:

"(b) Every license plate must display the registration number assigned to the vehicle for which it is issued, the name of the State of North Carolina, which may be abbreviated, and the year number for which it is issued or the date of expiration. A plate issued for a commercial vehicle, as defined in G.S. 20-4.2(1), and weighing 26,001 pounds or more, must bear the word "commercial," unless the plate is a special registration plate authorized in G.S. 20-79.4 or the commercial vehicle is a trailer or is licensed for 6,000 pounds or less. The plate issued for vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word "weighted," unless the plate is a special registration plate authorized in G.S. 20-79.4.

Except as otherwise provided in this subsection, a registration plate issued by the Division for a private passenger vehicle or for a private hauler vehicle licensed for 6,000 pounds or less shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight" printed at the top of the plate above all other letters and numerals. The background of the plate shall depict the Wright Brothers biplane flying over Kitty Hawk Beach, with the plane flying slightly upward and to the right. The following special registration plates do not have to be a "First in Flight" plate. The design of the plates that are not "First in Flight" plates must be approved by the Division and the State Highway Patrol for clarity and ease of identification.

SECTION 2. G.S. 20-79.4 is amended by adding a new subsection to read:

"(a3) The Division shall develop, in consultation with the State Highway Patrol and the Department of Correction, a standardized format for special license plates. The format shall allow for the license plate number to be easily read by the human eye and by cameras installed along roadways as part of tolling and speed enforcement. A designated segment of the plate shall be set aside for unique design representing various groups and interests. Nothing in this subsection shall be construed to require the recall of existing special license plates."

SECTION 3. G.S. 20-79.4(b) reads as rewritten:

"(b) Types. – The Division shall issue the following types of special registration plates:

37 shall bear the phrase "Mayor" and the letter "M" followed by a number that

40 that assigns number one to the first municipality in the list, except that
41 municipalities incorporated with an effective date after July 1, 2009, shall be
42 placed at the end of the list in order of date of incorporation. The Division

41 **SECTION 4.** G.S. 20-79.7(a) reads as rewritten:

42 "(a) Fees. – Upon request, the Division shall provide and issue free of charge a single

43 Legion of Valor, 100% Disabled Veteran, and Ex-Prisoner of War registration plate to a

44 recipient of a Legion of Valor award, a 100% disabled veteran, and an ex-prisoner of war each

45 year. The preceding special registration plates are subject to the regular motor vehicle

46 registration fees in G.S. 20-88, if the registered weight of the vehicle is greater than 6,000

47 pounds. All other special registration plates are subject to the regular motor vehicle registration

16 the "Boy Scouts of America" plate before the plate may be developed. The Division shall
17 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
18 from the sale of "Boy Scouts of America" plates to the Old Hickory Council of the Boy Scouts
19 of America, where the proceeds will be divided equally among the Boy Scouts of America
20 Councils in this State to be used for educational programs, preservation programs, capital
21 improvements on facilities located in this State, and related administrative and operating
22 expenses.

23 **(b79) Brenner Children's Hospital.** – The Division must receive 300 or more applications
24 for the "Brenner Children's Hospital" plate before the plate may be developed. The Division
25 shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account
26 derived from the sale of "Brenner Children's Hospital" plates to the NCBH Special
27 Purpose-Pediatric Unit Fund to provide funding for Brenner Children's Hospital.

28 **(b80) Carolina Raptor Center.** – The Division must receive 300 or more applications for a
29 "Carolina Raptor Center" plate before the plate may be developed. The Division must transfer
30 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
31 sale of "Carolina Raptor Center" plates to the Carolina Raptor Center to be used for educational
32 materials, preservation programs, capital improvements for the Carolina Raptor Center, and
33 operating expenses of the Carolina Raptor Center.

34 **(b81) Carolina Regional Volleyball Association.** – The Division must receive 300 or more
35 applications for the "Carolina Regional Volleyball Association" plate before the plate may be
36 developed. The Division must transfer quarterly the money in the Collegiate and Cultural
37 Attraction Plate Account derived from the sale of the "Carolina Regional Volleyball
38 Association" plates to the Carolina Regional Volleyball Association to promote and develop the
39 sport of volleyball throughout North Carolina.

40 **(b82) Carolinas Credit Union Foundation.** – The Division must receive 300 or more
41 applications for the "Carolinas Credit Union Foundation" plate before the plate may be
42 developed. The Division shall transfer quarterly the money in the Collegiate and Cultural
43 Attraction Plate Account derived from the sale of "Carolinas Credit Union Foundation" plates
44 to the Carolinas Credit Union Foundation, Inc., for youth-focused programs.

45 **(b83) Carolinas Golf Association.** – The Division must receive 300 or more applications
46 for the "Carolinas Golf Association" plate before the plate may be developed. The Division
47 shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account
48 derived from the sale of "Carolinas Golf Association" plates to the Carolinas Golf Association
49 to be used to promote amateur golf in North Carolina.

50 **(b84) Choose Life.** – The Division must receive 300 or more applications for a "Choose
51 Life" plate before the plate may be developed. The Division shall transfer quarterly the money

1 in the Collegiate and Cultural Attraction Plate Account derived from the sale of "Choose Life"
2 plates to the Carolina Pregnancy Care Fellowship, which shall distribute the money annually to
3 nongovernmental, not-for-profit agencies that provide pregnancy services that are limited to
4 counseling and/or meeting the physical needs of pregnant women. Funds received pursuant to
5 this section shall not be distributed to any agency, organization, business, or other entity that
6 provides, promotes, counsels, or refers for abortion and shall not be distributed to any entity
7 that charges women for services received.

8 (b85) Coastal Land Trust. – The Division must receive 300 or more applications for the
9 "Coastal Land Trust" plate before the plate may be developed. The Division shall transfer
10 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
11 sale of the "Coastal Land Trust" plates to the North Carolina Coastal Land Trust to be used to
12 acquire open space and natural areas, to ensure conservation education, to promote good land
13 stewardship, to set aside lands for conservation, and for other administrative and operating
14 costs.

15 (b86) Concerned Bikers Association/ABATE of North Carolina. – The Division must
16 receive 300 or more applications for the "Concerned Bikers Association/ABATE of North
17 Carolina" plate before the plate may be developed. The Division shall transfer quarterly the
18 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of the
19 "Concerned Bikers Association/ABATE of North Carolina" plates to the Department of Public
20 Instruction to support the driver training and safety education program established pursuant to
21 G.S. 115C-215 and to support motorcycle safety and awareness training as part of the driver
22 training program.

23 (b87) Daniel Stowe Botanical Garden. – The Division must receive 300 or more
24 applications for the "Daniel Stowe Botanical Garden" plate before the plate may be developed.
25 The Division must transfer quarterly the money in the Collegiate and Cultural Attraction Plate
26 Account derived from the sale of "Daniel Stowe Botanical Garden" plates to the Daniel Stowe
27 Botanical Garden Foundation, Inc., to provide funding for the Daniel Stowe Botanical Garden
28 outreach program.

29 (b88) Donate Life. – The Division must receive 300 or more applications for the "Donate
30 Life" plate before the plate may be developed. The Division must transfer quarterly the money
31 in the Collegiate and Cultural Attraction Plate Account derived from the sale of "Donate Life"
32 plates to Donate Life North Carolina to be divided equally among Donate Life North Carolina
33 and each of the transplant centers in North Carolina to include Bowman Gray Medical Center,
34 Carolinas Medical Center, Duke University, East Carolina University, and the University of
35 North Carolina at Chapel Hill. The transplant centers shall use all of the proceeds received from
36 this plate to provide funding for expenses incurred by needy families, recipients, and expenses
37 related to organ donation.

38 (b89) Farmland Preservation. – The Division must receive 300 or more applications for
39 the "Farmland Preservation" plate before the plate may be developed. The Division must
40 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
41 from the sale of "Farmland Preservation" plates to the North Carolina Agricultural
42 Development and Farmland Preservation Trust Fund established pursuant to G.S. 106-744.

43 (b90) First in Turf. – The Division must receive 300 or more applications for the "First in
44 Turf" plate before the plate may be developed. The Division shall transfer quarterly the money
45 in the Collegiate and Cultural Attraction Plate Account derived from the sale of "First in Turf"
46 plates to the Center for Environmental Turfgrass Research at North Carolina State University
47 for its programs.

48 (b91) Girl Scouts. – The Division must receive 300 or more applications for the "Girl
49 Scouts" plate before the plate may be developed. The Division shall transfer quarterly the
50 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of "Girl
51 Scouts" plates to the Girl Scouts North Carolina Coastal Pines, where the proceeds will be

1 divided equally among the officially chartered Girl Scout Councils in this State to be used for
2 educational programs, preservation programs, capital improvements on facilities located in this
3 State, and related administrative and operating expenses.

4 (b92) Home of American Golf. – The Division must receive 300 or more applications for
5 the "Home of American Golf" plate before the plate may be developed. The Division must
6 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
7 from the sale of "Home of American Golf" plates to the Given Memorial Library, Inc., to
8 provide funding for the Given Memorial Library – The Tufts Archives.

9 (b93) Jaycees. – The Division must receive 300 or more applications for the "Jaycees"
10 plate before the plate may be developed. The Division shall transfer quarterly the money in the
11 Collegiate and Cultural Attraction Plate Account derived from the sale of "Jaycees" plates to
12 the North Carolina JCI Senate, Inc., to be used to support and underwrite Jaycee activities in
13 North Carolina.

14 (b94) Mountains-to-Sea Trail. – The Division must receive 300 or more applications for
15 the "Mountains-to-Sea Trail" plate before the plate may be developed. The Division shall
16 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
17 from the sale of "Mountains-to-Sea Trail" plates to the Friends of the Mountains-to-Sea Trail,
18 Inc., to be used to fund trail projects and related administrative and operating expenses.

19 (b95) NC Beekeepers. – The Division must receive 300 or more applications for the "NC
20 Beekeepers" plate before the plate may be developed. The Division shall transfer quarterly the
21 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of "NC
22 Beekeepers" plates to North Carolina State University for research on the importance of bees to
23 agriculture and the State's agricultural economy.

24 (b96) NC Civil War. – The Division must receive 300 or more applications for the "NC
25 Civil War" plate before the plate may be developed. The Division must transfer quarterly the
26 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of "NC
27 Civil War" plates to the North Carolina Department of Cultural Resources, Division of
28 Archives and History, to provide funding to acquire, interpret, and preserve North Carolina's
29 Civil War history.

30 (b97) NC Fisheries Association. – The Division must receive 300 or more applications for
31 a "NC Fisheries Association" plate before the plate may be developed. The Division must
32 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
33 from the sale of "NC Fisheries Association" plates to the NC Fisheries Association to facilitate
34 the promotion of North Carolina families, heritage, and seafood through accessible data about
35 the ever-changing commercial fishing industry.

36 (b98) NC Horse Council. – The Division must receive 300 or more applications for the
37 "NC Horse Council" plate before the plate may be developed. The Division shall transfer
38 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
39 sale of "NC Horse Council" plates to the North Carolina Horse Council, Inc., to promote and
40 enhance the equine industry in North Carolina.

41 (b99) NC Mining. – The Division must receive 300 or more applications for the "NC
42 Mining" plate before the plate may be developed. The Division must transfer quarterly the
43 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of "NC
44 Mining" plates to the North Carolina Gold Foundation, Inc., to provide funding for information
45 and education about mining in North Carolina.

46 (b100) NC Veterinary Medical Association. – The Division must receive 300 or more
47 applications for the "NC Veterinary Medical Association" plate before the plate may be
48 developed. The Division shall transfer quarterly the money in the Collegiate and Cultural
49 Attraction Plate Account derived from the sale of "NC Veterinary Medical Association" plates
50 to the Friends of NCVMA Foundation, Inc., to be used to provide compassionate, quality health

1 care for all animals, to protect the health of the public, to strengthen the human-animal bond,
2 and to provide advanced continuing education for the public.

3 (b101) NC Victim Assistance Network. – The Division must receive 300 or more
4 applications for a "NC Victim Assistance Network" plate before the plate may be developed.
5 The Division must transfer quarterly the money in the Collegiate and Cultural Attraction Plate
6 Account derived from the sale of "NC Victim Assistance Network" plates to the NC Victim
7 Assistance Network to support the mission of the NC Victim Assistance Network to provide
8 support and information for crime victims across the State and to advocate for their fair
9 treatment.

10 (b102) NC Wildlife Federation. – The Division must receive 300 or more applications for
11 the "NC Wildlife Federation" plate before the plate may be developed. The Division shall
12 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
13 from the sale of "NC Wildlife Federation" plates to the North Carolina Wildlife Federation,
14 Inc., to provide funding for a grassroots program to involve anglers, hunters, and wildlife
15 enthusiasts in conservation issues affecting North Carolina.

16 (b103) North Carolina Emergency Management Association. – The Division must receive
17 300 or more applications for the "North Carolina Emergency Management Association" plate
18 before the plate may be developed. The Division shall transfer quarterly the money in the
19 Collegiate and Cultural Attraction Plate Account derived from the sale of "North Carolina
20 Emergency Management Association" plates to the North Carolina Emergency Management
21 Association to be used for training and education purposes.

22 (b104) North Carolina Master Gardener. – The Division must receive 300 or more
23 applications for the "North Carolina Master Gardener" plate before the plate may be developed.
24 The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
25 Account derived from the sale of "North Carolina Master Gardener" plates to the Master
26 Gardener's Endowment Fund maintained by the Agricultural Foundation of North Carolina
27 State University, to be used for educational programs by trained volunteers who work in
28 partnership with their county Cooperative Extension offices to extend information in consumer
29 horticulture.

30 (b105) Outer Banks Preservation Association. – The Division must receive 300 or more
31 applications for an "Outer Banks Preservation Association" plate before the plate may be
32 developed. The Division must transfer quarterly the money in the Collegiate and Cultural
33 Attraction Plate Account derived from the sale of "Outer Banks Preservation Association"
34 plates to the Outer Banks Preservation Association to facilitate the protection of the public's
35 right to access beaches in North Carolina.

36 (b106) Pamlico-Tar River Foundation. – The Division must receive 300 or more
37 applications for the "Pamlico-Tar River Foundation" plate before the plate may be developed.
38 The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
39 Account derived from the sale of "Pamlico-Tar River Foundation" plates to the Pamlico-Tar
40 River Foundation, Inc., to provide funding for the cleanup, preservation, and oversight of the
41 Pamlico and Tar Rivers, and their watersheds and basins.

42 (b107) P.E.O. Sisterhood. – The Division must receive 300 or more applications for the
43 "P.E.O. Sisterhood" plate before the plate may be developed. The Division shall transfer
44 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
45 sale of "P.E.O. Sisterhood" plates to P.E.O. International to be used for scholarships for young
46 women.

47 (b108) Phi Beta Sigma Fraternity. – The Division must receive 300 or more applications for
48 the "Phi Beta Sigma Fraternity" plate before the plate may be developed. The Division shall
49 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
50 from the sale of "Phi Beta Sigma Fraternity" plates to the Phi Beta Sigma Fraternity, Inc., to
51 provide funding for scholarships, education and professional development, or similar programs.

1 None of the proceeds from this special plate may be distributed to any board member as
2 compensation or as an honorarium.

3 (b109) Piedmont Airlines. – The Division must receive 300 or more applications for a
4 "Piedmont Airlines" plate before the plate may be developed. The Division must transfer
5 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
6 sale of "Piedmont Airlines" plates to Piedmont Silver Eagles Charitable Funds, Inc., to be used
7 for scholarships and family assistance for Piedmont Airlines employees and their families,
8 including surviving spouses and dependents, suffering economic hardship.

9 (b110) Ronald McDonald House. – The Division must receive 300 or more applications for
10 the "Ronald McDonald House" plate before the plate may be developed. The Division shall
11 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
12 from the sale of "Ronald McDonald House" plates to Ronald McDonald House Charities of
13 North Carolina, Inc., to be used for Ronald McDonald Houses located within North Carolina
14 and related administrative and operating expenses.

15 (b111) S.T.A.R. – The Division must receive 300 or more applications for the "S.T.A.R."
16 plate before the plate may be developed. The Division shall transfer quarterly the money in the
17 Collegiate and Cultural Attraction Plate Account derived from the sale of "S.T.A.R." plates to
18 Save the Animals Rescue, Inc., to provide funding to rescue distressed horses.

19 (b112) Support NC Education. – The Division must receive 300 or more applications for
20 the "Support NC Education" plate before the plate may be developed. The Division shall
21 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
22 from the sale of "Support NC Education" plates to the Board of Governors of The University of
23 North Carolina to be used to provide scholarship funding at the 16 constituent universities of
24 The University of North Carolina.

25 (b113) Support Soccer. – The Division must receive 300 or more applications for the
26 "Support Soccer" plate before the plate may be developed. The Division shall transfer quarterly
27 the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of
28 "Support Soccer" plates to the North Carolina Soccer Hall of Fame, Inc., to provide funding to
29 promote the sport of soccer in North Carolina.

30 (b114) Toastmasters Club. – The Division must receive 300 or more applications for the
31 "Toastmasters Club" plate before the plate may be developed. The Division shall transfer
32 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
33 sale of the "Toastmasters Club" plates to Toastmasters International to be used to help North
34 Carolinians communicate more effectively, improve presentation skills, and develop leadership
35 potential.

36 (b115) Topsail Island Shoreline Protection. – The Division must receive 300 or more
37 applications for the "Topsail Island Shoreline Protection" plate before the plate may be
38 developed. The Division shall transfer quarterly the money in the Collegiate and Cultural
39 Attraction Plate Account derived from the sale of "Topsail Island Shoreline Protection " plates
40 proportionately to the Town of North Topsail Beach, the Town of Surf City, and the Town of
41 Topsail Beach to be used for support of the Topsail Island Shoreline Protection Committee and
42 beach nourishment programs or projects for the three towns on Topsail Island.

43 (b116) Travel and Tourism. – The Division must receive 300 or more applications for the
44 "Travel and Tourism" plate before the plate may be developed. The Division shall transfer
45 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
46 sale of "Travel and Tourism" plates to the Division of Tourism, Film, and Sports Development
47 to be used for programs in support of travel and tourism in North Carolina."

48 **SECTION 8.** Chapter 20 of the General Statutes is amended by adding a new
49 section to read:

50 **"§ 20-79.8. Expiration of special registration plate authorization.**

1 (a) Expiration. – A special registration plate authorized pursuant to G.S. 20-79.4 shall
2 expire, as a matter of law, on July 1 of the second calendar year following the year in which the
3 special plate was authorized if the number of required applications for the authorized special
4 plate has not been received by the Division. The Division shall not accept applications for nor
5 advertise any special registration plate that has expired pursuant to this section.

6 (b) Notification. – The Division shall notify the Revisor of Statutes in writing, not later
7 than July 15 of each year, which special registration plate authorizations have expired as a
8 matter of law pursuant to subsection (a) of this section. The Division shall publish a copy of the
9 written notification sent to the Revisor of Statutes pursuant to this subsection on a Web site
10 maintained by the Division or the Department of Transportation.

11 (c) Revisor of Statutes Responsibilities. – Upon notification of expiration of the
12 authorization for any special registration plate by the Division pursuant to this section, the
13 Revisor of Statutes shall verify that the authorization for each special registration plate listed
14 has expired and shall notate such expiration in the applicable statutes. If an authorization for a
15 special registration plate listed in G.S. 20-79.4 expires, the Revisor of Statutes shall revise the
16 subdivision referring to the special registration plate to leave the name of the special
17 registration plate authorized and the date the special registration plate's authorization expired. If
18 an authorization for a special registration plate listed in G.S. 20-79.4 expires, the Revisor of
19 Statutes shall also make corresponding changes to reflect the expiration of the special
20 registration plate's authorization, if applicable, in G.S. 20-63(b), 20-79.7, and 20-81.12."

21 **SECTION 9.** Notwithstanding Section 8 of this act, any special registration plate
22 authorized in G.S. 20-79.7, prior to July 1, 2011, shall expire, as a matter of law, on July 1,
23 2013, if the number of applications required for the production of the special registration plate
24 has not been received by the Division of Motor Vehicles on or before that date. Upon
25 notification of expiration of the authorization for any special plate by the Division pursuant to
26 this section, the Revisor of Statutes shall verify that the authorization for each special
27 registration plate listed has expired and shall notate such expiration in the applicable statutes. If
28 an authorization for a special registration plate listed in G.S. 20-79.4 expires, the Revisor of
29 Statutes shall revise the subdivision referring to the special registration plate to leave the name
30 of the special plate authorized and the date the special registration plate's authorization expired.
31 If an authorization for a special registration plate listed in G.S. 20-79.4 expires, the Revisor of
32 Statutes shall also make corresponding changes to reflect the expiration of the special
33 registration plate's authorization, if applicable, in G.S. 20-63(b), 20-79.7, and 20-81.12.

34 **SECTION 10.** The Revisor of Statutes is authorized to alphabetize, number, and
35 renumber the special registration plates listed in G.S. 20-79.4 to ensure that all the special
36 registration plates are listed in alphabetical order and numbered accordingly.

37 **SECTION 11.** Section 8 of this act becomes effective July 1, 2011. The remainder
38 of this act is effective when it becomes law.
