Short Title: "Order of the Eastern Star" Special Plate. (Public)

A BILL TO BE ENTITLED
AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE AN
"ORDER OF THE EASTERN STAR PRINCE HALL AFFILIATED" SPECIAL
REGISTRATION PLATE.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-79.4(b) reads as rewritten:

"(b) Types. – The Division shall issue the following types of special registration plates:

...

() Order of the Eastern Star Prince Hall Affiliated. – Issuable to an active member of the Order of the Eastern Star Prince Hall Affiliated. The plate shall bear the Order of the Eastern Star Prince Hall Affiliated logo.

...."

SECTION 2. G.S. 20-79.7 reads as rewritten:

"§ 20-79.7. Fees for special registration plates and distribution of the fees.

...

(a1) Fees. – All other special registration plates are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. 6 (b159) Order of the Eastern Star Prince Hall Affiliated. – The Division shall transfer quarterly
7 the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of "Order
8 of the Eastern Star Prince Hall Affiliated" plates to the Grand Chapter Order of the Eastern Star,
9 PHA.

11 **SECTION 4.** The Revisor of Statutes is authorized to alphabetize, number, and
12 renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special
13 registration plates are listed in alphabetical order and numbered accordingly.

14 **SECTION 5.** This act becomes effective July 1, 2018.
