A BILL TO BE ENTITLED

AN ACT TO CRIMINALIZE THE ACT OF CAUSING A PERSON UNDER EIGHTEEN
YEARS OF AGE TO BE PRESENT AT AN EXHIBITION FEATURING ANIMAL
FIGHTING AND TO EXPAND THE SCOPE OF THE CRIME OF COCKFIGHTING.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 14-362 reads as rewritten:

"§ 14-362. Cockfighting.

- (a) A person who instigates, promotes, conducts, is employed at, allows property under his ownership or control to be used for, participates as a spectator at, causes a person under 18 years of age to be present at, or profits from from, an exhibition featuring the fighting of a cock is guilty of a Class I felony. A lease of property that is used or is intended to be used for an exhibition featuring the fighting of a cock is void, and a lessor who knows this use is made or is intended to be made of his property is under a duty to evict the lessee immediately.
- (b) A person who owns, possesses, trains, buys, sells, offers to buy or sell, or transports a cock, with intent that the cock be used in an exhibition featuring the fighting of that cock with another cock or another animal, is guilty of a Class I felony.
- (c) A person who owns, possesses, buys, sells, transfers, or manufactures cock fighting paraphernalia for the purpose of engaging in or otherwise promoting or facilitating the fighting or baiting of a cock is guilty of a Class 2 misdemeanor. For purposes of this subsection, the term "cock fighting paraphernalia" means gaffs, slashers, heels, or any other sharp implement designed to be attached in place of the natural spur of a cock or game fowl.
- (d) Each violation of this section constitutes a separate offense and shall not merge with any other offense."

SECTION 2. G.S. 14-362.1 reads as rewritten:

\$ 14-362.1. Animal fights and baiting, other than cock fights, dog fights and dog baiting.

(c) A person who participates as a spectator at at, or causes a person under 18 years of age to be present at, an exhibition featuring the fighting or baiting of an animal, other than a cock or a dog, is guilty of a Class 2 misdemeanor.

SECTION 3. G.S. 14-362.2 reads as rewritten:

"§ 14-362.2. Dog fighting and baiting.
