2 AN ACT TO AUTHORIZE AND REGULATE WAGERING ON PROFESSIONAL,
3 COLLEGE, AND AMATEUR SPORTS AND ON HORSE RACING IN NORTH
4 CAROLINA, AND TO AUTHORIZE LIVE HORSE RACING IN NORTH CAROLINA.

5 The General Assembly of North Carolina enacts:

6 SECTION 1. Chapter 18C of the General Statutes is amended by adding a new
7 Article to read:

8 "Article 9.

9 "Sports Wagering.

10 "**§ 18C-901. Definitions.**

11 As used in this Article, the following definitions apply:

- 12 (1) Amateur sports. – A sporting competition that is not a professional sport,
13 college sport, or youth sport. This term includes domestic, international, and
14 Olympic sporting competitions.
- 15 (2) Cash equivalent. – An asset convertible to cash for use in connection with
16 authorized sports wagering that includes all of the following:
17 a. Foreign currency and coin.
18 b. Personal check and draft.
19 c. Digital, crypto, and virtual currency.
20 d. Online and mobile payment systems that support online money
21 transfers.
22 e. Credit card and debit card.
23 f. Prepaid access instrument.
24 g. Any other form approved by the Commission.
- 25 (3) College sports. – An athletic or sporting competition in which at least one
26 participant is a team or contestant competing on behalf of or under the
27 sponsorship of a public or private institution of postsecondary education. This
28 term shall not include a public or private institution of postsecondary
29 education sponsorship of professional sports.
- 30 (4) Covered services. – Any service creating sports wagering markets and
31 determination of sports wager outcomes that involves the operation,
32 management, or control of sports wagers authorized by this Article. The term
33 shall not include any of the following:



- 1 a. Payment processing and similar financial services.
- 2 b. Customer identity, age verification, and geolocation services.
- 3 c. Streaming or other video and data that does not include the
4 determination of odds or line information.
- 5 d. Telecommunications, internet service providers, and other similar
6 services not specifically designed for sports wagering.
- 7 e. Other goods or services not specifically designed for use in connection
8 with sports wagering.
- 9 (5) Electronic sports. – Leagues, competitive circuits, tournaments, or similar
10 competitions where individuals or teams play video games, typically for
11 spectators, either in person or online, for prizes, money, or entertainment.
- 12 (6) Geofencing. – Technology approved by the Commission and utilized by an
13 interactive sports wagering operator to verify a registered player's geolocation
14 prior to the time the registered player is placing a sports wager.
- 15 (7) Gross wagering revenue. – The total of amounts received by an interactive
16 sports wagering operator from sports wagers as authorized under this Article
17 less the amounts paid as winnings before any deductions for expenses, fees,
18 or taxes.
- 19 (8) Interactive account. – A mobile account established by a registered player for
20 the purpose of placing sports wagers in accordance with this Article.
- 21 (9) Interactive sports wagering operator. – The holder of an interactive sports
22 wagering license issued by the Commission.
- 23 (10) Key person. – An officer or director of a licensee or applicant for licensure
24 who is directly involved in the operation, management, or control of sports
25 wagering authorized under this Article, or who exercises substantial influence
26 or control over the sports wagering activities.
- 27 (11) Official league data. – Statistics, results, outcomes, and other data relating to
28 a sporting event obtained pursuant to an agreement with the relevant sports
29 governing body or an entity expressly authorized by the relevant sports
30 governing body to provide such data.
- 31 (12) Pari-mutuel wager. – As defined in G.S. 18C-1001.
- 32 (13) Professional sports. – An athletic or sporting competition involving at least
33 two competitors who receive compensation for participating in such event.
- 34 (14) Registered player. – An individual who has established an interactive account
35 with an interactive sports wagering operator.
- 36 (15) Service provider. – A business entity that provides covered services to an
37 interactive sports wagering operator and holds a service provider license.
- 38 (16) Sporting event. – Professional sports, amateur sports, and college sports, all
39 of which may include electronic sports, and any other event approved by the
40 Commission.
- 41 (17) Sports facility. – Any of the following:
 - 42 a. A motorsports facility that annually hosts more than one National
43 Association for Stock Car Auto Racing national touring race.
 - 44 b. A facility that hosts a professional golf tournament with more than
45 50,000 live spectators anticipated to attend based on similar prior
46 tournaments.
 - 47 c. A facility that is the home location of a professional sports team that
48 competes in any of the following professional leagues:
 - 49 1. Major League Baseball.
 - 50 2. Major League Soccer.
 - 51 3. National Basketball Association.

- 1 4. National Football League.
2 5. National Hockey League.
3 6. National Women's Soccer League.
4 (18) Sports governing body. – An organization headquartered in the United States
5 that prescribes final rules with respect to a sporting event and enforces the
6 code of conduct for participants therein. In the context of electronic sports, the
7 sports governing body shall be the video game publisher of the title used in
8 the electronic sports competition, regardless of location.
9 (19) Sports wager or sports wagering. – Placing of wagers on any of the following:
10 (i) a sporting event, (ii) a portion of a sporting event, or (iii) the individual
11 performance statistics of athletes in a sporting event or combination of
12 sporting events. The term also includes single-game wagers, teaser wagers,
13 parlays, over-under, moneyline, pools, exchange wagering, in-game
14 wagering, in-play wagers, proposition wagers, straight wagers, and any other
15 wager approved by the Commission.
16 (20) Sports wagering brand. – The names, logos, and brands that an interactive
17 sports wagering operator advertises, promotes, or otherwise holds out to the
18 public displaying its sports wagering platform.
19 (21) Sports wagering platform. – A website, mobile application, or other
20 interactive platform accessible via the internet, mobile, wireless, or similar
21 communication technology that a registered player may use to place sports
22 wagers authorized under this Article.
23 (22) Sports wagering supplier. – A person that provides services, goods, software,
24 or other components necessary for the creation of sports wagering markets
25 and determination of sports wager outcomes, directly or indirectly, to any
26 interactive sports wagering operator or service provider involved in the
27 acceptance of sports wagers, including any of the following: providers of data
28 feeds and odds services, internet platform providers, risk management
29 providers, integrity monitoring providers, entities engaged in facilitating or
30 enabling sports wagering activities on behalf of, or in affiliation with,
31 interactive sports wagering operators in places of public accommodation, and
32 other providers of sports wagering supplier services as determined by the
33 Commission. The term does not include a sports governing body that provides
34 raw statistical match data to one or more designated and licensed providers of
35 data and odds services.
36 (23) Tier one sports wager. – A sports wager that is determined solely by the final
37 score or final outcome of the sporting event and is placed before the sporting
38 event has begun.
39 (24) Tier two sports wager. – Any sports wager that is not a tier one sports wager.
40 (25) Tribal gaming enterprise. – A federally recognized Indian tribe that is
41 authorized to conduct Class III games in accordance with the federal Indian
42 Gaming Regulatory Act, 25 U.S.C. § 2701 et seq., in this State or a business
43 entity owned or controlled by such tribe. Any federally recognized tribe, or
44 business entity owned or controlled by the tribe, that is deemed an interactive
45 sports wagering operator under this Article shall include authorization for any
46 technology and sports wagering brand partners of the tribe or the business
47 entity owned or controlled by the tribe, subject to compliance with the terms
48 of this Article by the technology and sports wagering brand partners.
49 (26) Youth sports. – An event in which the majority of participants are under the
50 age of 18 or are competing on behalf or under the sponsorship of one or more

1 public or private preschool, elementary, middle, or secondary schools. The
2 term does not include the following:

- 3 a. Professional sports.
- 4 b. Sporting events that occur under the sponsorship or oversight of
5 national or international athletic bodies that are not educational
6 institutions and that include participants both over and under the age
7 of 18.

8 **"§ 18C-902. Authorization of sports wagering generally.**

9 (a) Notwithstanding any provision of Article 37 of Chapter 14 of the General Statutes,
10 sports wagering as authorized by this Article shall not be considered unlawful. All sports
11 wagering authorized under this Article shall be placed via an interactive account or at a place of
12 public accommodation and shall be initiated and received within this State except as provided in
13 G.S. 18C-928. The interactive sports wagering operator shall comply with all of the following:

14 (1) Ensure that the registered player is located within the State, and not present
15 on Indian lands within the State, when placing any sports wager, by utilizing
16 geofencing.

17 (2) Monitor and block attempts to place unauthorized sports wagers.

18 (b) This Article does not apply to interactive sports wagering conducted exclusively on
19 Indian lands by an Indian tribe operating in accordance with a Tribal-State gaming compact and
20 authorized to conduct Class III gaming pursuant to a compact with the State. For purposes of this
21 Article, sports wagering is conducted exclusively on Indian lands only if the individual who
22 places the sports wager is physically present on Indian lands when the sports wager is initiated
23 and received by an Indian tribe operating on the same Indian lands in accordance with a
24 Tribal-State gaming compact and in conformity with the safe harbor requirements as provided in
25 31 U.S.C. § 5362(10)(c).

26 (c) An interactive sports wagering operator licensed under G.S. 18C-904 shall not, by
27 virtue of such licensure, be authorized to accept any sports wager if the registered player placing
28 the sports wager is physically present on Indian lands when the sports wager is initiated and
29 received. An interactive sports wagering operator licensed under G.S. 18C-904 shall be
30 authorized to accept a sports wager only if the registered player placing the sports wager is
31 physically present in this State when the sports wager is initiated and received. Each interactive
32 sports wagering operator licensed under G.S. 18C-904 shall use geofencing approved by the
33 Commission to ensure compliance with this Article.

34 (d) Nothing in this Article shall authorize any of the following:

35 (1) Sports wagering involving youth sports.

36 (2) Sports wagering on any of the following:

37 a. The occurrence of injuries.

38 b. The occurrence of penalties.

39 c. The outcome of disciplinary proceedings against a participant in a
40 sporting event.

41 d. The outcome of replay reviews.

42 (3) The Commission serving as an operator of a sports wagering platform.

43 (4) The placing of a pari-mutuel wager.

44 (e) Nothing in this Article shall apply to fantasy or simulated games or contests in which
45 one or more fantasy contest players compete and winning outcomes reflect the relative
46 knowledge and skill of the fantasy contest players and are determined predominantly by
47 accumulated statistical results of the performance of individuals, including athletes in the case of
48 sporting events.

49 (f) Upon request and with reasonable notice, the Commission or the Department of
50 Revenue has the authority to audit any interactive sports wagering operator or its service
51 providers as related to sports wagering activities.

1 (g) Any sports governing body on whose sporting events sports wagering is authorized
2 by this Article may enter into commercial agreements with interactive sports wagering operators
3 or other entities in which the sports governing body may share in the amount bet from sports
4 wagering on sporting events of the sports governing body. A sports governing body is not
5 required to obtain a license or any other approval from the Commission to lawfully accept such
6 amounts.

7 (h) Nothing in this Chapter shall authorize the Commission to establish, require, or
8 enforce a maximum or minimum payout or hold percentage upon any interactive sports wagering
9 operator.

10 (i) All of the following persons are prohibited from engaging in sports wagering:

11 (1) Any person under the age of 21.

12 (2) Any person who has requested and not revoked a voluntary exclusion
13 designation from sports wagering pursuant to G.S. 18C-922.

14 (3) Any person who has been adjudicated by law as prohibited from engaging in
15 sports wagering.

16 (4) Any member or employee of the Commission when placing a sports wager in
17 this State.

18 (5) Any employee or key person of an interactive sports wagering operator or
19 service provider license when placing sports wagers with that interactive
20 sports wagering operator.

21 (6) With respect to a sporting event, any participant in that sporting event,
22 including an athlete, coach, trainer, official, or any employee or staff of a
23 participant, when placing a sports wager on that sporting event in which that
24 participant is participating.

25 (7) Any employee or staff of a sports governing body, when placing a sports
26 wager on sporting events with which that individual or sports governing body
27 is affiliated.

28 **"§ 18C-903.** Reserved for future codification purposes.

29 **"§ 18C-904. Interactive sports wagering license.**

30 (a) It shall be unlawful for any person to offer or accept sports wagers in this State without
31 a valid interactive sports wagering license. Except as provided in G.S. 18C-928, the Commission
32 shall authorize no more than 12 interactive sports wagering operators to offer and accept sports
33 wagers on sporting events, which shall include any of the following:

34 (1) Professional sports.

35 (2) College sports.

36 (3) Electronic sports.

37 (4) Amateur sports.

38 (5) Any other event approved by the Commission in accordance with this Article.

39 (b) The Commission shall review and issue sports wagering licenses to qualified
40 applicants. The applicant shall complete and submit an application on a form prescribed by the
41 Commission and a licensing fee of one million dollars (\$1,000,000). If the application is denied,
42 the licensing fee shall be refunded, minus five percent (5%) of the licensing fee which shall be
43 used by the Commission to offset associated expenses in reviewing the application.

44 (c) The application shall set forth all of the following:

45 (1) The proposed initial business plan, including the range of contemplated types
46 and modes of sports wagering.

47 (2) The proposed measures to address age and identity verification and
48 geolocation requirements.

49 (3) The proposed internal controls that will prevent ineligible persons from
50 participating in sports wagering.

- 1 (4) A documented history of working to prevent compulsive gambling, including
2 training programs for its employees.
- 3 (5) A written information security program detailing information security
4 governance and the designation of a chief security officer or equivalent.
- 5 (6) The proposed sports wagering brand that the applicant plans to hold out to the
6 public displaying its sports wagering platform.
- 7 (7) Any personal information the Commission may deem necessary concerning
8 the applicant's key persons.
- 9 (8) A documented history of job creation in this State and a plan for continued
10 job creation in this State.
- 11 (9) A documented history of capital investment in this State and a plan for
12 continued capital investment in this State.
- 13 (10) A documented history of partnership with a sports facility, if any, and the
14 intentions of that partnership to offer the placement of sports wagers at a place
15 of public accommodation in accordance with this Article.
- 16 (11) Any other information the Commission may deem necessary.

17 (d) Information provided to the Commission under subdivisions (8) through (10) of
18 subsection (c) of this section are informational in nature and intended to provide additional
19 insight regarding applicants who intend to operate a place of public accommodation.

20 (e) The Commission shall conduct a background investigation on the applicant and key
21 persons as deemed necessary by the Commission. The background investigation shall include a
22 credit history check, a tax record check, and a criminal history record check. In the event an
23 applicant and its key persons have had a completed criminal history record check in the 12
24 months prior to the application, the Commission may, in its discretion, accept the results of that
25 prior criminal history record check upon submission of an affidavit that there has been no change
26 in criminal history since the prior criminal history record check in this or any other state. The
27 Commission shall not award a license if an applicant or any key person of the applicant has been
28 convicted of a felony or any gambling offense in any state or federal court of the United States
29 within 10 years of application or renewal.

30 (f) An applicant for licensure and any key person deemed necessary by the Commission
31 shall consent to a criminal history record check and shall submit all necessary fingerprints.
32 Refusal to consent to a criminal history record check may constitute grounds for the Commission
33 to deny licensure.

34 (g) The Commission shall grant or deny all applications under this section. The grounds
35 for denial of an interactive sports wagering license shall be the same as in G.S. 18C-906(g). If
36 there are more qualified applicants than the number of interactive sports wagering operators
37 authorized under subsection (a) of this section, the Commission shall select the best qualified
38 applicants, taking into consideration the following factors:

- 39 (1) The contents of the application submitted in accordance with this section.
- 40 (2) The extent to which the applicant demonstrates past experience, financial
41 viability, compliance with applicable laws and regulations in other
42 jurisdictions, and success with sports wagering operations in other
43 jurisdictions.
- 44 (3) The extent to which the applicant is able to meet the duties of an interactive
45 sports wagering operator.
- 46 (4) The amount of gross wagering revenue and associated tax revenue that an
47 applicant is projected to generate.
- 48 (5) The extent to which the applicant, or an affiliate of the applicant, will create
49 jobs in conjunction with sports wagering in this State.
- 50 (6) The extent to which the applicant, or an affiliate of the applicant, has made
51 capital investments in this State, and the timing of such capital investments.

1 (7) The extent to which the applicant, or an affiliate of the applicant, has a plan to
2 open and operate a place of public accommodation in accordance with this
3 Article.

4 (8) Any other factors the Commission deems relevant.

5 (h) A person holding a license to conduct sports wagering, on the basis of comparable
6 licensing requirements issued to that person by a proper authority in another state or territory of
7 the United States or the District of Columbia if that jurisdiction's requirements for licensure,
8 certification, or registration are substantially equivalent to or exceed the requirements of this
9 State, and who, in the opinion of the Commission otherwise meets the requirements of this Article
10 based upon verified evidence may, upon application, be licensed as an interactive sports wagering
11 operator with or without further examination, as determined by the Commission. The
12 Commission may also accept another jurisdiction's or approved third party's testing of the
13 interactive sports wagering platform as evidence that the sports wagering platform meets any
14 requirements mandated by the Commission.

15 (i) The Commission shall review and issue interactive sports wagering licenses to
16 qualified applicants within 60 days of receipt of a completed application. The Commission may
17 extend the review period for an additional 30 days if the background investigation is outstanding.
18 Any denial shall be in writing and state the grounds therefor.

19 (j) Notwithstanding Chapter 132 of the General Statutes or any other provision of law,
20 except for G.S. 18C-916(b), only the following documents under this section shall be a public
21 record, with respect to each applicant and each interactive sports wagering operator:

22 (1) The name, address, and sports wagering platform.

23 (2) The names of all key persons.

24 (3) The documented history of working to prevent compulsive gambling,
25 including training programs for its employees.

26 (4) The proposed sports wagering brand that the applicant plans to hold out to the
27 public displaying its sports wagering platform.

28 (5) The granting or denial of the application.

29 (k) Each interactive sports wagering operator shall promptly report all criminal or
30 disciplinary proceedings commenced against that interactive sports wagering operator in
31 connection with its operations to the Commission. Each interactive sports wagering operator shall
32 promptly report to the Commission all changes in key persons, and all new key persons shall
33 consent to a background investigation.

34 (l) No interactive sports wagering operator license is assignable or transferable without
35 approval of the Commission and payment of the licensing fee in accordance with this section.

36 (m) Interactive sports wagering operators shall assure the financial integrity of sports
37 wagering operations by the maintenance of a reserve of not less than five hundred thousand
38 dollars (\$500,000) or the amount required to cover the outstanding liabilities for sports wagers
39 accepted by the interactive sports wagering operator, whichever is greater. The reserve may take
40 the form of a bond, an irrevocable letter of credit, payment processor reserves and receivables,
41 cash or cash equivalents segregated from operational funds, guaranty letter, a combination
42 thereof, or any other means as approved by the Commission. Such reserve shall be adequate to
43 pay winning sports wagers when due. An interactive sports wagering operator is presumed to
44 have met this requirement if the operator maintains, on a daily basis, a minimum reserve in an
45 amount which is at least equal to the average daily minimum reserve, calculated on a monthly
46 basis, for the corresponding month in the previous year. For purposes of this subsection,
47 "outstanding liabilities for sports wagers accepted by an interactive sports wagering operator"
48 shall mean the amounts accepted by the interactive sports wagering operator on sports wagers
49 whose outcomes have not been determined and amounts owed but unpaid on winning sports
50 wagers.

1 (n) The holder of an interactive sports wagering operator license shall be deemed to also
2 hold a service provider license and sports wagering supplier license under this Article for
3 services, goods, software, or components provided in-house.

4 (o) If an applicant for an interactive sports wagering license is a sports facility or team
5 that is a member of a league, association, or organization that prevents the sports facility or team
6 from being subject to the regulatory control of the Commission or from otherwise operating under
7 an interactive sports wagering license, the sports facility or team may contractually appoint a
8 designee approved by the Commission for all aspects of Commission oversight and operation.

9 "**§ 18C-905.** Reserved for future codification purposes.

10 "**§ 18C-906. Applications for service provider licenses.**

11 (a) It shall be unlawful for any person to provide covered services to any interactive
12 sports wagering operator in this State without a valid service provider license. An interactive
13 sports wagering operator who provides covered services in-house shall not be required to have a
14 service provider license in addition to the interactive sports wagering operator license.

15 (b) The Commission shall review and issue service provider licenses to qualified
16 applicants within 60 days of receipt of a completed application. The Commission may extend the
17 review period for an additional 30 days if the background investigation is outstanding. Any denial
18 shall be in writing and state the grounds therefor. The applicant shall submit the completed
19 application, on a form prescribed by the Commission, and the licensing fee of fifty thousand
20 dollars (\$50,000). If the application is denied, the licensing fee shall be refunded, minus five
21 percent (5%) of the licensing fee which shall be used by the Commission to offset associated
22 expenses in reviewing the application.

23 (c) The application shall set forth all of the following:

24 (1) The applicant's background in sports wagering or the covered service.

25 (2) All experience with sports wagering or other wagering activities in other
26 jurisdictions, including the applicant's history, reputation of integrity and
27 compliance, and a list of all active and inactive licenses, certifications, or
28 registrations and reasons for inactivity, if applicable.

29 (3) A written information security program, detailing information security
30 governance and the designation of a chief security officer or equivalent.

31 (4) Any personal information the Commission may deem necessary concerning
32 the applicant's key persons.

33 (5) Any other information the Commission may deem necessary.

34 (d) The Commission shall conduct a background investigation on the applicant and key
35 persons as deemed necessary by the Commission. The background investigation shall include a
36 credit history check, a tax record check, and a criminal history record check. In the event an
37 applicant and its key persons have had a completed criminal history record check in the 12
38 months prior to the application, the Commission may, in its discretion, accept the results of that
39 prior criminal history record check upon submission of an affidavit that there has been no change
40 in criminal history since the prior criminal history record check in this or any other state. The
41 Commission shall not award a license if the applicant or any key person of the applicant has been
42 convicted of a felony or any gambling offense in any state or federal court of the United States
43 within 10 years of application or renewal.

44 (e) An applicant for licensure and any key person deemed necessary by the Commission
45 shall consent to a criminal history record check and shall submit all necessary fingerprints.
46 Refusal to consent to a criminal history record check may constitute grounds for the Commission
47 to deny licensure.

48 (f) A person holding a service provider license or its equivalent, on the basis of
49 comparable licensing requirements issued to that person by a proper authority by another state or
50 territory of the United States or the District of Columbia if that jurisdiction's requirements for
51 licensure, certification, or registration are substantially equivalent to or exceed the requirements

1 of this State, and who, in the opinion of the Commission otherwise meets the requirements of
2 this Article based upon verified evidence may, upon application, be licensed as a service provider
3 with or without further examination, as determined by the Commission.

4 (g) Grounds for denial of a license may include the following:

5 (1) The applicant is unable to satisfy the requirements under this Article.

6 (2) The applicant or any key person is not of good character, honesty, or integrity.

7 (3) The applicant's or any key person's prior activities, criminal record, reputation,
8 or associations indicate any of the following:

9 a. A potential threat to the public interest.

10 b. The potential to impede the regulation of sports wagering.

11 c. The potential of promoting unfair or illegal activities in the conduct of
12 sports wagering.

13 (4) The applicant or any key person knowingly makes a false statement of
14 material fact or deliberately fails to disclose information requested by the
15 Commission.

16 (5) The applicant or any key person knowingly fails to comply with the provisions
17 of this Article or any requirements of the Commission.

18 (6) The applicant or any key person was convicted of a felony, a crime of moral
19 turpitude, or any criminal offense involving dishonesty or breach of trust
20 within the 10 years prior to the submission date of the application.

21 (7) Any revocation, suspension, or denial of the applicant's or key person's
22 license, certification, or registration to conduct sports wagering, other forms
23 of gambling activity, or a covered service issued by any other jurisdiction.

24 (8) The applicant has defaulted on any obligation or debt owed to this State.

25 (h) Notwithstanding Chapter 132 of the General Statutes or any other provision of law,
26 except for G.S. 18C-916(b), only the following documents under this section shall be a public
27 record, with respect to each applicant and each service provider:

28 (1) The name, address, and sports wagering platform.

29 (2) The name of all key persons.

30 (3) The granting or denial of the application.

31 (i) Each service provider shall promptly report all criminal or disciplinary proceedings
32 commenced against that service provider in connection with its operations to the Commission.
33 Each service provider shall promptly report all changes in key persons to the Commission, and
34 all new key persons shall consent to a background investigation.

35 (j) No service provider license is assignable or transferable without approval of the
36 Commission.

37 **"§ 18C-907. Sports wagering supplier license.**

38 (a) The Commission may issue a sports wagering supplier license to a sports wagering
39 supplier.

40 (b) At the request of an applicant for a sports wagering supplier license, the Commission
41 may issue a provisional sports wagering supplier license to the applicant so long as the applicant
42 has submitted a completed application in accordance with this section. A provisional license
43 issued under this subsection expires on the date provided by the Commission.

44 (c) A person may apply to the Commission for a sports wagering supplier license as
45 provided in this Article.

46 (d) The applicant shall complete and submit an application on a form prescribed by the
47 Commission and a licensing fee of thirty thousand dollars (\$30,000). If the application is denied,
48 the licensing fee shall be refunded, minus five percent (5%) of the licensing fee which shall be
49 used by the Commission to offset associated expenses in reviewing the application. In the
50 application, the Commission shall require applicants to disclose the identity of each of the
51 following:

- 1 (1) The applicant's principal owners who directly own ten percent (10%) or more
2 of the applicant.
- 3 (2) Each holding, intermediary, or parent company that directly owns fifteen
4 percent (15%) or more of the applicant.
- 5 (3) The applicant's board appointed CEO and CFO, or the equivalent as
6 determined by the Commission.
- 7 (4) Any other information the Commission may deem necessary.
- 8 (e) The Commission shall conduct a background investigation on the applicant, key
9 persons of the applicant, and current employees of the applicant, as deemed necessary by the
10 Commission. The background investigation shall include a credit history check, a tax record
11 check, and a criminal history record check. In the event an applicant and its key persons have
12 had a completed criminal history record check in the 12 months prior to the application, the
13 Commission may, in its discretion, accept the results of that prior criminal history record check
14 upon submission of an affidavit that there has been no change in criminal history since the prior
15 criminal history record check in this or any other state. The Commission may not award a license
16 if the applicant or a key person of the applicant has been convicted of a felony or any gambling
17 offense in any state or federal court of the United States within 10 years of application or renewal.
- 18 (f) An applicant for licensure and any key person deemed necessary by the Commission
19 shall consent to a criminal history record check and shall submit all necessary fingerprints.
20 Refusal to consent to a criminal history record check may constitute grounds for the Commission
21 to deny licensure.
- 22 (g) The Commission shall review and issue licenses to qualified applicants within 60 days
23 of receipt of a completed application. The Commission may extend the review period for an
24 additional 30 days if the background investigation is outstanding.
- 25 (h) In disclosing the principal owners of the applicant, the following shall apply:
- 26 (1) Governmental created entities, including statutory authorized pension
27 investment boards and Canadian Crown corporations, that are direct or
28 indirect shareholders of an applicant shall be waived in the applicant's
29 disclosure of ownership and control as determined by the Commission.
- 30 (2) Investment funds or entities registered with the Securities and Exchange
31 Commission, including Investment Advisors and entities under the
32 management of the Securities and Exchange Commission, that are direct or
33 indirect shareholders of the applicant shall be waived in the applicant's
34 disclosure of ownership and control as determined by the Commission.
- 35 (i) A sports wagering supplier license or a provisional sports wagering supplier license
36 shall be sufficient to offer the sports wagering services under this Article.
- 37 (j) A person holding a sports wagering supplier license or its equivalent, on the basis of
38 comparable licensing requirements issued to that person by a proper authority by another state or
39 territory of the United States or the District of Columbia if that jurisdiction's requirements for
40 licensure, certification, or registration are substantially equivalent to or exceed the requirements
41 of this State, and who, in the opinion of the Commission otherwise meets the requirements of
42 this Article based upon verified evidence may, upon application, be licensed as a sports wagering
43 supplier with or without further examination, as determined by the Commission.
- 44 (k) Each sports wagering supplier shall promptly report all criminal or disciplinary
45 proceedings commenced against that sports wagering supplier in connection with its operations
46 to the Commission. Each sports wagering supplier shall promptly report to the Commission all
47 changes in key persons, and all new key persons shall consent to a background investigation.
- 48 (l) Notwithstanding Chapter 132 of the General Statutes or any other provision of law,
49 except for G.S. 18C-916(b), only the following documents under this section shall be a public
50 record, with respect to each applicant and each sports wagering supplier:
- 51 (1) The name, address, and sports wagering platform.

1 (2) The name of all key persons.
2 (3) The granting or denial of the application.
3 (m) No sports wagering supplier license is assignable or transferable without approval of
4 the Commission and payment of the licensing fee in accordance with this section.

5 **"§ 18C-908. Renewals of licenses.**

6 (a) Any license issued pursuant to this Article shall be valid for five years.
7 (b) At least 60 days prior to the expiration of a license, the license holder shall submit a
8 renewal application, on a form prescribed by the Commission, including a renewal fee as follows:

9 (1) One million dollars (\$1,000,000) for an interactive sports wagering license.

10 (2) Fifty thousand dollars (\$50,000) for a service provider license.

11 (3) Thirty thousand dollars (\$30,000) for a sports wagering supplier license.

12 (c) The Commission may revoke or deny a license renewal for any of the following
13 reasons:

14 (1) The same grounds that would constitute denial of an initial application under
15 G.S. 18C-906(g).

16 (2) A violation of this Article or a pattern of noncompliance with rules or
17 directives promulgated by the Commission.

18 (3) Failure to pay the tax imposed under Article 2E of Chapter 105 of the General
19 Statutes.

20 (4) The Commission's previous decision to suspend or impose civil penalties on
21 the licensee.

22 (d) With respect to interactive sports wagering operators, the Commission may deny a
23 license renewal if the Commission finds good cause that the licensee has materially not complied
24 with the provisions of this Article.

25 (e) The Commission may, in its discretion, require an annual attestation of compliance
26 from licensees. The Commission shall prescribe the form, method, and deadline of the attestation
27 of compliance. To the extent a licensee identifies any instance of technical or material
28 noncompliance in its annual attestation of compliance, it shall also submit a remedial or
29 mitigation plan for the Commission's consideration.

30 **"§ 18C-909. Use of proceeds.**

31 (a) The Commission shall use the funds remitted to it pursuant to G.S. 105-113.128 and
32 any proceeds from license fees collected under this Article and Article 10 of this Chapter to cover
33 expenses in administering this Article. Any proceeds remaining at the end of each fiscal year
34 after payment of expenses of the Commission pursuant to this section shall be remitted to the
35 General Fund.

36 (b) Expenses of the Commission shall include all items listed in G.S. 18C-163.

37 **"§ 18C-910. Duties of licensees.**

38 (a) The interactive sports wagering operator and its service providers shall make
39 commercially reasonable efforts to do all of the following:

40 (1) Prevent persons who are not registered players from placing sports wagers
41 through its sports wagering platform.

42 (2) Prevent persons who are not physically located in the State from placing a
43 wager through its sports wagering platform.

44 (3) Protect the confidential information of registered players using its sports
45 wagering platform.

46 (4) Prevent sports wagering on prohibited events set forth in this Article or as
47 otherwise determined by the Commission.

48 (5) Prevent persons from placing sports wagers as agents or proxies for others.

49 (6) Allow persons to voluntarily exclude themselves under G.S. 18C-922 from
50 placing sports wagers through its sports wagering platform as set forth in this
51 Article.

- 1 (7) Establish procedures to detect suspicious or illegal sports wagering activity.
2 (8) Provide for the reporting of income tax on winnings where required by
3 applicable State or federal law.
4 (9) Prevent a participant in a sporting event, including an athlete, coach, trainer,
5 official, or any employee or staff of a participant from placing a sports wager
6 on that sporting event in which the participant is participating.
7 (10) Verify the location of the sports wagerer at the time the sports wager is
8 initiated and received for compliance with G.S. 18C-902(c).
9 (b) For three years after a sporting event occurs, interactive sports wagering operators
10 shall maintain records on all of the following:
11 (1) Each sports wager, including the identity of the registered player placing the
12 sports wager.
13 (2) The amount, type, time, location, and outcome of the sports wager, including
14 the IP address, if available.
15 (3) Suspicious or illegal sports wagering activity.
16 (c) The interactive sports wagering operator shall disclose the records described in
17 subsection (b) of this section to the Commission upon request.
18 (d) If a sports governing body has notified the Commission that real-time information
19 sharing for sports wagers placed on its sporting events is necessary, interactive sports wagering
20 operators shall share with that sports governing body or its designee in real time, at the account
21 level, anonymized information regarding a registered player, amount and type of sports wager,
22 the time the sports wager was placed, the location of the registered player at the time the sports
23 wager was placed, the IP address if applicable, the outcome of the sports wager, and records of
24 abnormal sports wagering activity. For purposes of this subsection, real time means on a
25 commercially reasonable periodic interval, but in any event, not less than once every 72 hours.
26 A sports governing body receiving any information pursuant to this subsection shall use the
27 information for the purpose of integrity monitoring only and not for any commercial purpose.
28 (e) In advertising and marketing its sports wagering platform and related commercial
29 offerings, the interactive sports wagering operator, or those acting on its behalf, shall ensure that
30 advertisements and marketing messages and materials meet all of the following requirements:
31 (1) It does not target persons under the age of 21.
32 (2) It discloses the identity of the interactive sports wagering operator.
33 (3) It provides information about or links to resources related to gambling
34 addiction and prevention.
35 (4) It is not misleading to a reasonable person.
36 (5) It satisfies the rules and requirements promulgated by the Commission.
37 (f) Background investigations shall search for criminal history and any charges or
38 convictions involving corruption or manipulation of sporting events and association with
39 organized crime.
40 (g) Interactive sports wagering operators and service providers shall employ
41 commercially reasonable methods to maintain the security of wagering data, registered player
42 and other customer data, and any other confidential information, including information provided
43 by a sports governing body, from unauthorized access and dissemination. All servers necessary
44 to the placement or resolution of a sports wager, other than back-up servers, shall be physically
45 located in this State. Consistent with federal law, nothing in this section shall preclude the use of
46 internet or cloud-based hosting, or the use of back-up servers located outside of this State.
47 (h) Each interactive sports wagering operator shall provide a daily summary of all sports
48 wagering activity, detailing all transactions processed through each wagering system, provided
49 in a format established by the Commission, at the close of each business day.
50 (i) An interactive sports wagering operator may not, as a condition of use of its sports
51 wagering platform, require a registered player to waive any right, forum, or procedure otherwise

1 available to the registered player under State or federal law. All agreements between an
2 interactive sports wagering operator and a registered player shall be governed by State law. The
3 State and federal courts located in North Carolina shall serve as the exclusive venue for all such
4 disputes.

5 **"§ 18C-911.** Reserved for future codification purposes.

6 **"§ 18C-912. Establishment of interactive accounts.**

7 (a) Only a registered player shall be permitted to establish an interactive account with an
8 interactive sports wagering operator. The interactive sports wagering operator is responsible for
9 verifying the identity of the registered player and ensuring that the registered player is at least 21
10 years of age. The registered player shall be permitted to deposit cash or cash equivalents into the
11 interactive account.

12 (b) A registered player may not have more than one interactive account with each
13 interactive sports wagering operator.

14 (c) An interactive account shall meet all of the following requirements:

15 (1) Be registered in the name of the registered player, who is a natural person.

16 (2) Be established through the interactive sports wagering operator's sports
17 wagering platform.

18 (3) Be funded with cash or cash equivalents.

19 (4) Prohibit the transfer or sale of an account or account balance.

20 (5) Prohibit the use of any virtual private network or other technology that may
21 obscure or falsify the registered player's physical location.

22 (6) Prohibit any form of collusion, cheating, or other unlawful activity.

23 (7) Affirm that the registered player meets all eligibility requirements for
24 registration.

25 (8) Authorize the provision of notices and other required communications either
26 through a designated mobile or other interface or to an electronic mail address
27 designated by the registered player.

28 (9) Meet or exceed minimum requirements identified by the Commission,
29 including technical requirements related to data privacy, data security, and
30 sports wagering platform features to support responsible sports wagering.

31 (d) The interactive sports wagering operator shall put in place sufficient measures to
32 verify the age and identity of the registered player needed to allow the establishment of
33 interactive accounts remotely.

34 (e) An interactive account held by a registered player in this State may be suspended or
35 terminated by the interactive sports wagering operator under any of the following conditions:

36 (1) The registered player has provided any false or misleading information in
37 connection with the opening of the account, or has engaged in collusion,
38 cheating, or other unlawful conduct.

39 (2) The registered player is barred from placing sports wagers in the State.

40 (3) The registered player is or otherwise becomes ineligible pursuant to this
41 Article.

42 (4) For any other reason at the sole discretion of the interactive sports wagering
43 operator, provided it is not in violation of federal or State law.

44 (f) In the event of termination of the interactive account in accordance with this section,
45 the registered player shall be provided timely ability to access and withdraw any funds remaining
46 in the interactive account.

47 **"§ 18C-913.** Reserved for future codification purposes.

48 **"§ 18C-914. Integrity of competition and prohibited events.**

49 (a) A sports governing body may submit to the Commission in writing a request to
50 restrict, limit, or exclude a certain type, form, or category of sports wagering with respect to
51 sporting events of such body, if the sports governing body believes that such type, form, or

1 category of sports wagering with respect to sporting events of such body may undermine the
2 integrity or perceived integrity of such body or sporting events of such body. The Commission
3 shall request comment from interactive sports wagering operators on all such requests. After
4 giving due consideration to all comments received, the Commission shall, upon a demonstration
5 of good cause from the requestor that such type, form, or category of sports wagering is likely to
6 undermine the integrity or perceived integrity of such body or sporting events of such body, grant
7 the request. The Commission shall respond to a request concerning a particular event before the
8 start of the event, or if it is not feasible to respond before the start of the event, no later than seven
9 days after the request is made. If the Commission determines that the requestor is more likely
10 than not to prevail in successfully demonstrating good cause for its request, the Commission may
11 provisionally grant the request of the sports governing body until the Commission makes a final
12 determination as to whether the requestor has demonstrated good cause. Absent such a
13 provisional grant by the Commission, interactive sports wagering operators may continue to offer
14 sports wagering on sporting events that are the subject of such a request during the pendency of
15 the Commission's consideration of the applicable request.

16 (b) The Commission and interactive sports wagering operators shall cooperate with
17 investigations conducted by sports governing bodies or law enforcement agencies, including
18 using commercially reasonable efforts to provide or facilitate the provision of sports wagering
19 information. All disclosures under this section are subject to an interactive sports wagering
20 operator's obligations to comply with all federal, State, and local laws and regulations, including
21 those relating to privacy and personally identifiable information.

22 (c) Interactive sports wagering operators are not required to use official league data for
23 determining any of the following:

24 (1) The results of tier one sports wagers on sporting events of any organization
25 whether headquartered in the United States or elsewhere.

26 (2) The results of tier two sports wagers on sporting events of organizations that
27 are not headquartered in the United States.

28 (d) A sports governing body may notify the Commission that it desires interactive sports
29 wagering operators to use official league data to settle tier two sports wagers on sporting events
30 of such sports governing body. Notification shall be made in the form and manner as the
31 Commission may require. The Commission shall notify each interactive sports wagering operator
32 of a sports governing body's notification within five days of the Commission's receipt of the
33 notification. If a sports governing body does not so notify the Commission, an interactive sports
34 wagering operator is not required to use official league data for determining the results of tier
35 two sports wagers on sporting events of that sports governing body.

36 (e) Within 60 days of the Commission notifying each interactive sports wagering
37 operator of a sports governing body notification to the Commission, or longer period as may be
38 agreed between the sports governing body and the applicable interactive sports wagering
39 operator, interactive sports wagering operators shall use only official league data to determine
40 the results of tier two sports wagers on sporting events of that sports governing body, unless any
41 of the following apply:

42 (1) The sports governing body or its designee cannot provide a feed of official
43 league data to determine the results of a particular type of tier two sports
44 wager, in which case interactive sports wagering operators are not required to
45 use official league data for determining the results of the applicable tier two
46 sports wager until such time as such a data feed becomes available from the
47 sports governing body on commercially reasonable terms and conditions.

48 (2) An interactive sports wagering operator can demonstrate to the Commission
49 that the sports governing body or its designee will not provide a feed of official
50 league data to the interactive sports wagering operator on commercially
51 reasonable terms and conditions.

1 (3) The designee of the sports governing body does not obtain a sports wagering
2 supplier license from the Commission to provide official league data to
3 interactive sports wagering operators to determine the results of tier two sports
4 wagers, if and to the extent required by law.

5 (f) During the pendency of the Commission's determination as to whether a sports
6 governing body or its designee will provide a feed of official league data on commercially
7 reasonable terms, an interactive sports wagering operator is not required to use official league
8 data for determining the results of tier two sports wagers. The Commission's determination shall
9 be made within 60 days of the interactive sports wagering operator notifying the Commission
10 that it desires to demonstrate that the sports governing body or its designees will not provide a
11 feed of official league data to the sports wagering operator on commercially reasonable terms.
12 The following is a non-exclusive list of factors the Commission may consider in evaluating
13 whether official league data is being offered on commercially reasonable terms and conditions
14 for purposes of this subsection and subsections (d) and (e) of this section:

15 (1) The extent to which interactive sports wagering operators have purchased the
16 same or similar official league data on the same or similar terms, particularly
17 in jurisdictions where such purchase was not required by law, or was required
18 by law, but only if offered on commercially reasonable terms.

19 (2) The nature and quantity of the official league data, including its speed,
20 accuracy, reliability, and overall quality, as compared to comparable
21 non-official data.

22 (3) The quality and complexity of the process used to collect and distribute the
23 official league data as compared to comparable non-official data.

24 (4) The availability of a sports governing body's tier two official league data to an
25 interactive sports wagering operator from more than one authorized source.

26 (5) Market information, including price and other terms and conditions, regarding
27 the purchase by interactive sports wagering operators of comparable data for
28 the purpose of settling sports wagers in this State and other jurisdictions.

29 (6) The extent to which sports governing bodies or their designees have made data
30 used to settle tier two sports wagers available to interactive sports wagering
31 operators and any terms and conditions relating to the use of that data.

32 (7) Any other information the Commission deems relevant.

33 (g) Interactive sports wagering operators shall, as soon as practicable, report to the
34 Commission any information relating to abnormal betting activity or patterns that may indicate
35 a concern with the integrity of a sporting event or events, or any other conduct that corrupts a
36 sports wagering outcome of a sporting event or events for purposes of financial gain, including
37 match fixing. The interactive sports wagering operator making such a report shall also
38 simultaneously report such information to the relevant sports governing body.

39 "**§ 18C-915.** Reserved for future codification purposes.

40 "**§ 18C-916. Civil penalties; suspension and revocation of licenses.**

41 (a) If the Commission determines that the holder of a license under this Article has
42 violated any provision of this Article, the Commission, with at least 15 days' notice and a hearing,
43 may do either or both of the following:

44 (1) Suspend or revoke the license.

45 (2) Impose a monetary penalty of not more than ten thousand dollars (\$10,000)
46 for each violation.

47 (b) Nonpublic record documents and materials that applicants and licensees submit to the
48 Commission shall become public record if such materials are specifically identified by the
49 Commission as providing a basis for a civil penalty, license suspension, license revocation, or
50 other formal or informal enforcement action undertaken by the Commission against the licensee.

51 "**§ 18C-917.** Reserved for future codification purposes.

1 **"§ 18C-918. Criminal penalties.**

2 (a) Any person who knowingly offers or engages in sports wagering in violation of this
3 Article shall be guilty of a Class 2 misdemeanor.

4 (b) Any person under the age of 21 who engages in sports wagering as defined under this
5 Article shall be guilty of a Class 2 misdemeanor.

6 (c) Any person who knowingly attempts to suborn, collude, or otherwise conspire to
7 influence the outcome of any competition or aspect of any competition that is the subject of sports
8 wagering pursuant to this Article shall be guilty of a Class G felony.

9 (d) Any applicant for an interactive sports wagering license, a service provider license,
10 or sports wagering supplier license who willfully furnishes, supplies, or otherwise gives false
11 information on the license application shall be guilty of a Class I felony.

12 (e) Nothing in this Article shall be construed to allow the interactive sports wagering
13 operator or its service providers to be charged with a violation of subsection (a) or (c) of this
14 section absent actual notice and knowledge that a person is under age or giving false information.

15 **"§ 18C-919.** Reserved for future codification purposes.

16 **"§ 18C-920.** Reserved for future codification purposes.

17 **"§ 18C-921.** Reserved for future codification purposes.

18 **"§ 18C-922. Voluntary exclusion program.**

19 (a) The Commission shall establish a voluntary exclusion program for any individual to
20 voluntarily exclude themselves from placing sports wagers under this Article and pari-mutuel
21 wagers under Article 10 of this Chapter. Licensees under this Article and Article 10 of this
22 Chapter shall use reasonable means to comply with the exclusion of individuals participating in
23 the voluntary exclusion program by the Commission.

24 (b) The Commission shall adopt rules to establish the voluntary exclusion program,
25 which shall provide for all of the following:

26 (1) Verification of the individual's request to be placed in the voluntary exclusion
27 program, and for how long, up to and including that individual's lifetime.

28 (2) How information regarding which individuals are in the voluntary exclusion
29 program is to be disseminated to licensees under this Article and Article 10 of
30 this Chapter.

31 (3) How an individual in the voluntary exclusion program may petition the
32 Commission for removal from the voluntary exclusion program.

33 (4) The means by which licensees under this Article and Article 10 of this Chapter
34 and their agents shall make all reasonable efforts to cease direct marketing
35 efforts to individuals participating in the voluntary exclusion program.

36 (5) The means by which the Commission shall make available to all licensees
37 under this Article and Article 10 of this Chapter and their agents the names of
38 the individuals participating in the voluntary exclusion program, which shall
39 be at least quarterly.

40 (c) Participation in the voluntary exclusion program shall not preclude licensees under
41 this Article and Article 10 of this Chapter and their agents from seeking the payment of a debt
42 accrued by the individual while not participating in the voluntary exclusion program.

43 (d) The voluntary exclusion program shall be exempt from Chapter 132 of the General
44 Statutes and shall be treated as confidential by each licensee under this Article and Article 10 of
45 this Chapter. Licensees under this Article and Article 10 of this Chapter conducting sports
46 wagering or pari-mutuel wagering in another state may share the information provided under this
47 section with its agents and affiliates in other states for excluding individuals participating in the
48 voluntary exclusion program.

49 **"§ 18C-923.** Reserved for future codification purposes.

50 **"§ 18C-924. Risk management.**

1 The Commission shall adopt rules permitting, but not requiring, interactive sports wagering
2 operators and their service providers to employ systems that offset loss or manage or lay off risk
3 in the operation of sports wagering pursuant to this Article, including through liquidity pools,
4 exchanges, or similar mechanisms in another approved jurisdiction in which the interactive sports
5 wagering operator, service provider, or an affiliate of either or other third party also holds a
6 license or the equivalent, provided that at all times adequate protections are maintained to ensure
7 sufficient funds are available to pay all winnings.

8 **"§ 18C-925.** Reserved for future codification purposes.

9 **"§ 18C-926. Places of public accommodation.**

10 (a) Permanent places of public accommodation for the purpose of placing sports wagers
11 may be associated with each sports facility. Each sports facility may partner with one interactive
12 sports wagering operator to provide places of public accommodation.

13 (b) Permanent places of public accommodation permitted under this section shall be
14 located as follows:

15 (1) On the property of the sports facility.

16 (2) No more than one place of public accommodation may be on other property
17 owned or controlled by the owner or operator of the sports facility or an
18 affiliated entity of the owner or operator of the sports facility that is located
19 within a one-half mile radius of a sports facility as defined in
20 G.S. 18C-901(17)a. or G.S. 18C-901(17)c.

21 (3) No more than one place of public accommodation may be on other property
22 owned or controlled by the owner or operator of the sports facility that is
23 located within a one and one-half mile radius of a sports facility as defined in
24 G.S. 18C-901(17)b.

25 (c) Nothing in this section shall be construed to exempt a place of public accommodation
26 from the provisions of any other law that may be enforceable.

27 (d) Mobile devices, computer terminals, similar devices, and cashiers used to operate the
28 place of public accommodation shall have the ability to accept cash and cash equivalents and to
29 distribute cash or cash equivalents. Only a cashier may distribute cash or cash equivalents at a
30 place of public accommodation. All cashiers that accept or distribute cash or cash equivalents
31 shall be employees of an interactive sports wagering operator.

32 (e) A place of public accommodation under this section may be advertised by the owner
33 or operator of the sports facility. Such advertisements shall comply with the requirements listed
34 in G.S. 18C-910(e).

35 (f) Notwithstanding subsections (a) through (c) of this section, if a permanent place of
36 public accommodation is not located at the sports facility as defined in G.S. 18C-901(17)b. that
37 hosts the professional golf tournament, no more than one temporary place of public
38 accommodation may be established at the sports facility as defined in G.S. 18C-901(17)b. during

40 comply with local ordinances under Chapter 160D of the General Statutes. For purposes of this
41 subsection, "temporary" shall mean opening no more than five calendar days prior to the
42 professional golf tournament and closing no later than five calendar days after the professional
43 golf tournament.

44 (g) The Commission may adopt rules as necessary governing the placement of any place
45 of public accommodation on the property of a sports facility.

47 **"§ 18C-928. Compliance with federal law; Indian gaming.**

48 (a) Consistent with the intent of the United States Congress as articulated in the Unlawful
49 Internet Gambling Enforcement Act of 2006 (31 U.S.C. § 5361 et seq.), the intermediate routing
50 of electronic data relating to intrastate sports wagering authorized under this Article shall not
51 determine the location or locations in which such sports wagers are initiated and received.

1 (b) All activities authorized by this Article shall be deemed to be conducted solely under
2 the authority of this Article and not under the federal Indian Gaming Regulatory Act, 25 U.S.C.
3 § 2701 et seq.

4 (c) A tribal gaming enterprise shall be deemed a licensed interactive sports wagering
5 operator upon the occurrence of all of the following:

6 (1) Submission of a completed application to the Commission.

7 (2) Agreement by the tribal gaming enterprise, in a form as prescribed by the
8 Commission, to all of the following:

9 a. Adherence to the requirements of this Article and to the regulations
10 adopted by the Commission with respect to sports wagering.

11 b. Submission to the Commission's enforcement of this Article and any
12 implementation of the rules, including waiver of any applicable tribal
13 sovereign immunity for the sole and limited purpose of such
14 enforcement.

15 c. Collection and payment of all taxes imposed under Article 2E of
16 Chapter 105 of the General Statutes.

17 d. Not offering or conducting any interactive gambling other than the
18 sports wagering authorized by this Article unless specifically
19 otherwise authorized by law.

20 e. Location of any server or other information technology equipment
21 directly related to the placing of sports wagers that is used by the tribal
22 gaming enterprise and its agents to accept sports wagering authorized
23 by this Article on land that is not Indian lands. Upon request, make
24 accessible any server or other information technology equipment
25 directly related to the placing of sports wagers by the Commission, the
26 Department of Revenue, and State law enforcement. The location of
27 all other technology and servers used by a tribal gaming enterprise in
28 connection with sports wagering authorized by this Article shall be
29 approved by the Commission.

30 (d) Any federally recognized tribe, or business entity owned or controlled by the tribe,
31 that is deemed an interactive sports wagering operator under this Article shall include
32 authorization for any technology and sports wagering brand partners of the tribe or the business
33 entity owned or controlled by the tribe, subject to compliance with the terms of this Article by
34 the technology and sports wagering brand partners. A tribal gaming enterprise deemed an
35 interactive sports wagering operator under this section shall not count toward the total number of
36 authorized interactive sports wagering operators in this State in accordance with G.S. 18C-904."

47 (2) The purpose of this Part is to stimulate economic activity and to create new
48 jobs within the State.

49 (3) The enactment of this Part will maintain consistency and accountability in a
50 key economic development program and will ensure that the program benefits
51 the State and its citizens.

- 1 (4) Nothing in this Part shall be construed to constitute a guarantee or assumption
2 by the State of any debt of any business or to authorize the taxing power or
3 the full faith and credit of the State to be pledged.

4 **"§ 143B-437.111. Definitions.**

5 The following definitions apply in this Part:

- 6 (1) Fund. – The North Carolina Major Events, Games, and Attractions Fund
7 established under G.S. 143B-437.112.
- 8 (2) Local entity. – A city, county, or local organizing committee.
- 9 (3) Local organizing committee. – A nonprofit corporation or its successor in
10 interest that satisfies one of the following conditions:

- 33 (5) Site selection organization. – The organization responsible for determining
34 the site of a major event.
- 35 (6) Sports facility. – As defined in G.S. 18C-901.

36 **"§ 143B-437.112. North Carolina Major Events, Games, and Attractions Fund.**

37 (a) There is established the North Carolina Major Events, Games, and Attractions Fund
38 to be administered by the Department. In order to foster job creation and investment in the
39 economy of this State, the Department may enter into multiparty agreements with site selection
40 organizations and local entities to provide grants in accordance with the provisions of this Part.
41 Before entering into an agreement, the Department must find that all of the following conditions
42 are met:

- 43 (1) The economic activity directly or indirectly attributable to the major event is
44 sufficient to justify the use of State funds to attract or retain the event in this

7 for the area where it will be located.

11 the grant appropriate for the major event.

12 (b) Effective July 1 of each calendar year, the funds remitted to the Fund by the Secretary
13 of Revenue from the tax on sports wagering pursuant to G.S. 105-113.128 are appropriated for
14 this purpose. In addition to the amounts remitted to the Fund pursuant to G.S. 105-113.128, the
15 General Assembly shall determine any additional amount appropriated to the Fund. Agreements
16 entered under this section are subject to appropriations.

35 Division. The report shall include all of the following:

- 38 (2) An update on the status of major events for which grants have been awarded
39 but that have not yet occurred.

41 Department to implement this Part, a copy of the guidelines, and for
42 subsequent reports, identification of any changes to those guidelines from the

- 44 (4) The geographic distribution of grants, by number and amount, awarded under

- 46 (5) A listing of all local entities making an application under this Part and an
47 explanation of whether a site selection organization located the major event in
48 this State regardless of whether a grant for the event was awarded under this

50 (c) Study. – The Department shall conduct a study to determine the minimum funding
51 level required to implement the Fund successfully. The Department shall report the results of this

1 study to the House of Representatives Finance Committee, the Senate Finance Committee, the

3 the Senate Appropriations Committee on Natural and Economic Resources, and the Fiscal
4 Research Division no later than April 1 of each year.

22 upon submission of an affidavit that there has been no change in criminal history since the prior
23 criminal history record check in this or any other state. The Commission may not award a license
24 if the applicant or a person required to be disclosed on the application has been convicted of a
25 felony or any gambling offense in any state or federal court of the United States within 10 years

 9 with a violation of subsection (a) or (c) of this section absent actual notice and knowledge that a
 10 person is under age or giving false information.

4 (c) The Commission and the Department of Revenue may agree to exchange any data
5 necessary to enforce and administer Articles 9 and 10 of this Chapter and Article 2E of Chapter
6 105 of the General Statutes, including information deemed necessary to perform an audit of a
7 licensee or taxpayer under those Articles."

8 **SECTION 4.(b)** G.S. 18C-120(b) reads as rewritten:

4 "**§ 16-1. Gaming and betting contracts void.**

5 (a) All wagers, bets or stakes made to depend upon any race, or upon any gaming by lot
6 or chance, or upon any lot, chance, casualty or unknown or contingent event whatever, shall be
7 unlawful; and all contracts, judgments, conveyances and assurances for and on account of any
8 money or property, or thing in action, so wagered, bet or staked, or to repay, or to secure any
9 money, or property, or thing in action, lent or advanced for the purpose of such wagering, betting,
10 or staking as aforesaid, shall be void.

11 (b) This section shall not apply to:

12 (1) Any sports wager, as defined in G.S. 18C-901, placed in accordance with
13 Article 9 of Chapter 18C of the General Statutes.

14 (2) Any pari-mutuel wager, as defined in G.S. 18C-1001, placed in accordance
15 with Article 10 of Chapter 18C of the General Statutes."

16 **SECTION 4.(g)** G.S. 18C-102 reads as rewritten:

17 "**§ 18C-102. Purpose and intent.**

18 The General Assembly declares that the purpose of this Chapter is to establish a
19 State-operated lottery and to provide for the regulation of other sanctioned gaming enterprises in
20 order to generate funds for the public purposes described in this Chapter.~~Chapter~~ and to support
21 responsible gaming."

22 **SECTION 4.(h)** G.S. 18C-113(b) reads as rewritten:

23 "~~Except as provided in this Article, records~~ Records of the Commission shall be open
24 and available to the public in accordance with Chapter 132 of the General ~~Statutes.~~ Statutes,
25 except as provided in this Article or unless disclosure could be used to potentially (i) provide an
26 unfair advantage to a player or (ii) impair or adversely impact the security or integrity of the
27 operation of the Lottery, any of its games, or investigations into potentially fraudulent or other
28 activities in violations of any laws, Lottery rules, regulations, and policies."

29 **SECTION 4.(i)** G.S. 18C-122(c) reads as rewritten:

30 "(c) The portion of the security audit report containing specific recommendations shall be
31 confidential, shall be presented only to the Director and to the Commission, and shall be exempt
32 from Chapter 132 of the General Statutes. The Commission may hear the report of such an audit,
33 discuss, and take action on any recommendations to address that audit under
34 G.S. 143-318.11(a)(1). The Commission may hear reports on the following matters under
35 G.S. 143-318.11(a)(1), all of which shall be exempt from Chapter 132 of the General Statutes:

36 (1) Information regarding any vulnerabilities listed in subsection (a) of this
37 section.

38 (2) Information that could impair or adversely impact the security of the Lottery
39 or the Commission in carrying out its responsibilities as directed in this
40 Chapter.

41 (3) Information that could be used to provide an unfair advantage to a player or
42 jeopardize the integrity of any lottery game."

43 **SECTION 4.(j)** G.S. 18C-161(3) reads as rewritten:

44 "(3) All other funds credited or appropriated to the Commission from any
45 ~~source.~~ source, except as provided in Articles 9 and 10 of this Chapter."

46 **SECTION 4.(k)** G.S. 18B-1005 reads as rewritten:

47 "**§ 18B-1005. Conduct on licensed premises.**

48 (a) Certain Conduct. – It shall be unlawful for a permittee or ~~his~~ the permittee's agent or
49 employee to knowingly allow any of the following kinds of conduct to occur on ~~his~~ the licensed
50 premises:

51 (1) Any violation of this ~~Chapter.~~ Chapter.

- 1 (2) Any fighting or other disorderly conduct that can be prevented without undue
2 danger to the permittee, ~~his-the~~ permittee's employees or patrons; or patrons.
3 (3) Any violation of the controlled substances, gambling, or prostitution statutes,
4 or any other unlawful acts. For purposes of this subdivision, gambling shall
5 not include wagering exempted by G.S. 14-309.3.
6 (4) through (6) Repealed by Session Laws 2003-382, s. 1, effective August 1,
7 2003.

8 (b) Supervision. – It shall be unlawful for a permittee to fail to superintend in person or
9 through a manager the business for which a permit is issued."

10 **SECTION 5.** Chapter 105 of the General Statutes is amended by adding a new
11 Article to read:

12 "Article 2E.

13 "Tax on Interactive Sports Wagering Operators.

14 **"§ 105-113.125. Definitions.**

15 The definitions of G.S. 18C-901 apply to this Article.

16 **"§ 105-113.126. Tax on interactive sports wagering operators.**

17 (a) Tax. – A tax at the rate of eighteen percent (18%) is imposed on an interactive sports
18 wagering operator licensed under Article 9 of Chapter 18C of the General Statutes. The tax
19 applies to the gross wagering revenue of the interactive sports wagering operator.

20 (b) Carryforward. – If the amount of gross wagering revenue is a negative number for
21 any month, the interactive sports wagering operator may carry forward the negative amount to
22 the return filed for the subsequent month. No amount shall be carried forward more than 12
23 months after the month in which the amount carried forward was originally due.

24 (c) Return. – Taxes levied by this Article are due when a return is required to be filed.
25 The return is due on a monthly basis. A monthly return is due by the twentieth day of the month
26 following the calendar month covered by the return. A return is filed on a form prescribed by the
27 Secretary.

28 (d) Records. – A person who is required to file a return under this Article must keep a
29 record of all documents used to determine information the person provides in a return. These
30 records shall be open at all times for inspection by the Secretary or an authorized representative
31 of the Secretary and shall be kept for the applicable period of statute of limitations as set forth
32 under Article 9 of this Chapter.

33 (e) Refund. – An interactive sports wagering operator is allowed a refund of the tax paid
34 under this section on a sports wager that has been refunded. The Secretary shall prescribe the
35 manner in which an interactive sports wagering operator may request a refund under this
36 subsection, which may include allowing a credit for the amount refunded on a subsequent
37 monthly return required under this section.

38 **"§ 105-113.127. Bond or irrevocable letter of credit.**

39 The Secretary may require an interactive sports wagering operator to furnish a bond in an
40 amount that adequately protects the State from an interactive sports wagering operator's failure
41 to pay taxes due under this Article. A bond must be conditioned on compliance with this Article,
42 payable to the State, and in the form required by the Secretary. The amount of the bond is two
43 times the interactive sports wagering operator's expected monthly tax liability under this Article,
44 as determined by the Secretary, provided the amount of the bond may not be less than fifty
45 thousand dollars (\$50,000) and may not be more than two million dollars (\$2,000,000). The
46 Secretary should periodically review the sufficiency of bonds required of interactive sports
47 wagering operators and increase the amount of a required bond when the amount of the bond
48 furnished no longer covers the anticipated tax liability of the interactive sports wagering operator
49 and decrease the amount when the Secretary determines that a smaller bond amount will
50 adequately protect the State from loss.

1 For purposes of this section, an interactive sports wagering operator may substitute an
2 irrevocable letter of credit for the secured bond required by this section. The letter of credit must
3 be issued by a commercial bank acceptable to the Secretary and available to the State as a
4 beneficiary. The letter of credit must be in a form acceptable to the Secretary, conditioned upon
5 compliance with this Article, and in the amounts stipulated in this section.

6 **"§ 105-113.128. Use of tax proceeds.**

7 The Secretary shall distribute the taxes collected under this Article, less the allowance to the
8 Department of Revenue and reimbursement to the Lottery Commission for administrative
9 expenses, in accordance with this section. The Secretary may retain the cost of collection by the
10 Department, not to exceed five hundred thousand dollars (\$500,000) a year, as reimbursement to
11 the Department. The Lottery Commission shall, no later than 20 days after the end of the month,
12 notify the Department of its expenses from administering the provisions of Article 9 of Chapter
13 18C of the General Statutes from the previous month. The Department shall reimburse the
14 Lottery Commission from the tax revenues collected under this Article no later than the end of
15 the month in which the Department was notified. The remainder of the net proceeds of the tax
16 collected under this Article are to be credited in the following priority:

- 17 (1) Two million dollars (\$2,000,000) annually to the Department of Health and
18 Human Services for gambling addiction education and treatment programs.
- 19 (2) One million dollars (\$1,000,000) annually to North Carolina Amateur Sports
20 to expand opportunities for persons up to age 18 to engage in youth sports,
21 which shall be distributed through a grant program. In making individual
22 grants, North Carolina Amateur Sports shall comply with the following:
- 23 a. Awards shall be used to provide for the purchase of youth sports
24 equipment, or to provide for public facility upgrades or improvements
25 which would benefit youth sports.
- 26 b. Awards may be given only to applicants who are either local
27 governments or nonprofit organizations exempt from taxation under
28 section 501(c)(3) of the Internal Revenue Code.
- 29 c. Awards may be given only to applicants who demonstrate that a
30 primary purpose for the funding is to facilitate opportunities for
31 persons up to age 18 to engage in youth sports.
- 32 d. The total dollar amount awarded each year to all applicants in any one
33 county may not exceed one percent (1%) of the total funding available
34 on July 1 of that year.
- 35 (3) Three hundred thousand dollars (\$300,000) annually shall be appropriated to
36 each of the institutions listed in this subdivision to support collegiate athletic
37 departments. If there are not sufficient funds for each of these institutions to
38 receive an appropriation of three hundred thousand dollars (\$300,000), the
39 amount of each appropriation shall be reduced by the same proportion so that
40 all institutions receive an appropriation of the same amount. The institutions
41 are listed as follows:
- 42 a. Appalachian State University.
- 43 b. East Carolina University.
- 44 c. Elizabeth City State University.
- 45 d. Fayetteville State University.
- 46 e. North Carolina Agricultural & Technical State University.
- 47 f. North Carolina Central University.

- 49 h. University of North Carolina at Charlotte.
- 50 i. University of North Carolina at Greensboro.
- 51 j. University of North Carolina at Pembroke.

- 1 k. University of North Carolina at Wilmington.
- 2 l. Western Carolina University.
- 3 m. Winston-Salem State University.
- 4 (4) One million dollars (\$1,000,000) annually to the North Carolina Outdoor
- 5 Heritage Advisory Council for grants, in the discretion of the Council, as
- 6 follows:
- 7 a. Grants not to exceed five thousand dollars (\$5,000) per sporting team
- 8 or group per county per year requesting grant assistance to travel to
- 9 in-State or out-of-state sporting events.
- 10 b. Incentive grants not to exceed twenty-five thousand dollars (\$25,000)
- 11 to attract State, regional, area, and national sporting events,
- 12 tournaments, and programs for nonprofessional sporting participants
- 13 in programs administered by city, county, and local school
- 14 administrative units, or appropriate nonprofit organizations exempt
- 15 from taxation under section 501(c)(3) of the Internal Revenue Code as
- 16 determined by the North Carolina Outdoor Heritage Advisory
- 17 Council.
- 18 (5) Of the remaining proceeds, as follows:
- 19 a. Twenty percent (20%) annually to be distributed equally among the
- 20 institutions listed in this sub-subdivision to support collegiate athletic
- 21 departments, not to supplant general funding to that institution. The
- 22 institutions are listed as follows:
- 23 1. Appalachian State University.
- 24 2. East Carolina University.
- 25 3. Elizabeth City State University.
- 26 4. Fayetteville State University.
- 27 5. North Carolina Agricultural & Technical State University.
- 28 6. North Carolina Central University.
- 29 7. University of North Carolina at Asheville.
- 30 8. University of North Carolina at Charlotte.
- 31 9. University of North Carolina at Greensboro.
- 32 10. University of North Carolina at Pembroke.
- 33 11. University of North Carolina at Wilmington.
- 34 12. Western Carolina University.
- 35 13. Winston-Salem State University.
- 36 b. Thirty percent (30%) annually to the North Carolina Major Events,
- 37 Games, and Attractions Fund established under G.S. 143B-437.112.
- 38 c. Fifty percent (50%) annually to the General Fund."

39 **SECTION 5.1.** If Senate Bill 22 of the 2023 Regular Session of the General
 40 Assembly, or substantially similar legislation, becomes law, then G.S. 105-113.128(4) reads as
 41 rewritten:

- 42 "(4) One million dollars (\$1,000,000) annually to the North Carolina Youth
- 43 Outdoor ~~Heritage Advisory Council~~ Engagement Commission for grants, in
- 44 the discretion of the ~~Council~~, Commission, as follows:
- 45 a. Grants not to exceed five thousand dollars (\$5,000) per sporting team
- 46 or group per county per year requesting grant assistance to travel to
- 47 in-State or out-of-state sporting events.
- 48 b. Incentive grants not to exceed twenty-five thousand dollars (\$25,000)
- 49 to attract State, regional, area, and national sporting events,
- 50 tournaments, and programs for nonprofessional sporting participants
- 51 in programs administered by city, county, and local school

1 administrative units, or appropriate nonprofit organizations exempt
2 from taxation under section 501(c)(3) of the Internal Revenue Code as

5 **SECTION 5.5.** Article 51A of Chapter 14 of the General Statutes is amended by
6 adding a new section to read:

7 "**§ 14-380.5. Horse racing not prohibited.**

8 Horse racing, as authorized and regulated in accordance with Article 10 of Chapter 18C of
9 the General Statutes, shall not be considered a horse show for purposes of this Article."

10 **SECTION 6.** If any section or provision of this act is declared unconstitutional or
11 invalid by the courts, it does not affect the validity of this act as a whole or any part other than
12 the part so declared to be unconstitutional or invalid.

13 **SECTION 7.** The Commission shall establish guidance to parties regulated by the
14 provisions of Articles 9 and 10 of Chapter 18C of the General Statutes, as enacted by this act.
15 Such guidance shall address the application of Article 9 of Chapter 18C of the General Statutes,
16 as enacted by this act, to electronic sports with due consideration to the key role of game
17 publishers as creators of the underlying video game. When adopting rules under G.S. 18C-1025,
18 as enacted by this act, the Commission shall adopt rules providing guidance on the issuance,
19 denial, suspension, or revocation of a license provided under Article 10 of Chapter 18C of the
20 General Statutes as well as guidance on the operation of advance deposit account wagering by
21 ADW licensees. The Commission may adopt rules prior to January 8, 2024, however, no rule
22 may become effective until on or after that date. The Commission may accept and issue
23 applications for licensure in accordance with Articles 9 and 10 of Chapter 18C of the General
24 Statutes, as enacted by this act, prior to January 8, 2024, in order that licensees may begin
25 operations on January 8, 2024. If more than 12 completed interactive sports wagering operator
26 applications are received, the Commission shall select based upon the criteria set forth in
27 G.S. 18C-904(g), as enacted by this act, and notify the qualified applicants it determines will best
28 serve the public interest in maximizing revenue to the State, while preserving the integrity of
29 sports wagering and ensuring accountability and preserving the public trust in licensed sports
30 wagering activities. No license issued by the Commission shall become effective prior to January
31 8, 2024, however, sports wagering shall not be authorized in the State until a date identified by
32 the Commission, which shall occur as soon as practicable and may be no later than 12 months
33 after the date this act becomes law.

34 **SECTION 8.** The North Carolina State Lottery Commission shall use sufficient
35 funds from the North Carolina State Lottery Fund to cover initial operating expenses of the
36 Commission to implement Articles 9 and 10 of Chapter 18C of the General Statutes, as enacted
37 by this act, provided the total amount borrowed by the Commission shall not exceed fourteen
38 million dollars (\$14,000,000) without further action by the General Assembly. The Commission
39 shall repay any funds used out of the North Carolina State Lottery Fund pursuant to this section
40 within 36 months after the effective date of this act.

41 **SECTION 9.** The North Carolina State Lottery Commission shall study the
42 implementation of Articles 9 and 10 of Chapter 18C of the General Statutes, as enacted by this
43 act, and shall report its findings, with any legislative recommendations, to the Joint Legislative
44 Oversight Committee on the North Carolina State Lottery no later than March 1, 2024. The study
45 and report shall address all of the following:

- 46 (1) Restrictions on number of licensees as established by G.S. 18C-904, as
47 enacted by this act, and how additional applications for licensure are treated.
- 48 (2) Any potential challenges to enforcement of the Articles.
- 49 (3) The establishment and use of the voluntary exclusion program.
- 50 (4) The siting and opening of places of public accommodation and usage of such
51 sites.

- 1 (5) Any potential issues or challenges with audits of interactive sports wagering
2 operators and ADW licensees.
3 (6) Any other information the Commission deems relevant.
4 **SECTION 10.** Sections 1, 2, 3, 4, 5.5, and 6 of this act become effective January 8,
5 2024. Section 5 of this act becomes effective January 8, 2024, and applies to gross wagering
6 revenue received on or after that date. Except as otherwise provided, this act is effective when it
7 becomes law.
