2 AN ACT TO PROVIDE ADDITIONAL REGULATORY RELIEF TO THE CITIZENS OF  
3 NORTH CAROLINA.

4 The General Assembly of North Carolina enacts:

6 **PART I. OCCUPATIONAL LICENSING AND ADMINISTRATIVE PROCEDURES**

7  
8 **ESTABLISH THE NORTH CAROLINA HEALING ARTS COMMISSION AND TO**  
9 **CREATE LICENSURE PROCESSES FOR REFLEXOLOGISTS, MUSIC**  
10 **THERAPISTS, AND NATUROPATHIC DOCTORS**

11 **SECTION 1.(a)** Chapter 90 of the General Statutes is amended by adding a new  
12 Article to read:

13 "Article 44.

14 "Healing Arts.

15 "Part 1. North Carolina Healing Arts Commission.

16 **"§ 90-750.1. Title and purpose.**

17 (a) This Article shall be known and may be cited as the "North Carolina Healing Arts  
18 Act."

19 (b) The North Carolina Healing Arts Act is established to safeguard the public health,  
20 safety, and welfare; to protect the public from being harmed by unqualified persons; to assure  
21 the highest degree of professional services and conduct on the part of practitioners of the healing  
22 arts; to provide for the establishment of licensure requirements; and to ensure the availability of  
23 healing arts services of high quality to persons in need of such services.

24 **"§ 90-750.2. Definitions.**

25 The following definitions apply in this Article:

26 (1) Advisory committee. – A committee charged with supervising the day-to-day  
27 regulation of a healing arts profession. Advisory committees shall screen  
28 applicants for licensure and conduct all investigations necessary to give  
29 recommendations to the Commission.

30 (2) Commission. – The North Carolina Healing Arts Commission, as established  
31 pursuant to G.S. 90-750.3.

32 (3) Healing arts. – The use of allopathic, complementary, or alternative  
33 approaches to the art and science of medicine for the prevention,  
34 identification, and treatment of human physical or mental conditions, diseases,



1 ailments, illnesses, infirmities, pain, defects, or injuries and the promotion and  
2 restoration of health and wellness.

3 (4) Healing arts profession. – Any of the professions listed in G.S. 90-750.8.

4 (5) North Carolina Healing Arts License. – A license in a healing arts profession  
5 issued pursuant to this Article.

6 **"§ 90-750.3. North Carolina Healing Arts Commission; composition; terms; compensation.**

7 (a) Establishment. – The North Carolina Healing Arts Commission is hereby created. The  
8 Commission shall consist of the following members appointed to three-year terms as follows:

9 (1) One reflexologist appointed by the General Assembly upon the  
10 recommendation of the President Pro Tempore of the Senate.

11 (2) One music therapist appointed by the General Assembly upon the  
12 recommendation of the President Pro Tempore of the Senate or the Speaker  
13 of the House of Representatives, alternating each subsequent term.

14 (3) One naturopathic doctor appointed by the General Assembly upon the  
15 recommendation of the Speaker of the House of Representatives.

16 (4) One reflexologist appointed by the Governor.

17 (5) One music therapist appointed by the Governor.

18 (6) One naturopathic doctor appointed by the Governor.

19 (7) One member of the public appointed by the Governor.

20 (b) Vacancies. – Any vacancies on the Commission shall be filled by the appointing  
21 authority as provided in subsection (a) of this section, except that any vacancy in appointments  
22 by the General Assembly shall be filled in accordance with G.S. 120-122. Individuals appointed  
23 to fill vacancies shall serve until the normal expiration of the term they were appointed to fill.

24 (c) Qualifications. –

25 (1) All members appointed to the Commission shall be citizens of the United  
26 States and residents of the State of North Carolina.

27 (2) All members appointed to the Commission, except for the public member  
28 appointed by the Governor under subdivision (7) of subsection (a) of this  
29 section, shall be required to hold a North Carolina Healing Arts License in  
30 their respective profession, and remain in good standing for the duration of  
31 their terms.

32 (3) Public members of the Commission shall not be:

33 a. An agent or employee trained or experienced in the practice of healing  
34 arts.

35 b. An agent or employee of a person engaged in the practice of healing  
36 arts.

37 c. A spouse of an individual licensed pursuant to this Article.

38 d. Any person with significant financial interest in a health service or  
39 profession.

40 (d) New Healing Arts Professions. – Any healing arts professions created after January  
41 1, 2025, shall have two members on the Commission, both of whom shall serve three-year terms.  
42 One of these members shall be appointed by the Governor. The second member shall be  
43 appointed by the General Assembly. The Speaker of the House of Representatives shall make a  
44 recommendation to be approved by the General Assembly for the first term, and the President  
45 Pro Tempore of the Senate shall make a recommendation to be approved by the General  
46 Assembly for the second term. The Speaker of the House of Representatives and the President  
47 Pro Tempore of the Senate shall thereafter alternate recommendations for subsequent terms.

48 (e) Removal. – The Commission may remove any of its members for neglect of duty,  
49 incompetence, or unprofessional conduct. A member subject to disciplinary proceedings as a  
50 licensed healing arts professional shall be disqualified from participating in the official business

1 of the Commission until the charges have been resolved. Any member of the Commission may  
2 be removed from office by the Governor for good cause shown.

3 (f) Compensation of Members; Meetings. – A Commission member may not receive  
4 compensation but may receive reimbursement as provided in G.S. 93B-5. The officers of the  
5 Commission shall include a chair, a secretary, and any other officers deemed necessary by the  
6 Commission to carry out the purposes of this Article. All officers shall be elected annually by the  
7 Commission at its first meeting held after appointments to the Commission are made. The  
8 Commission shall hold a meeting within 45 days after the appointment of new Commission  
9 members. All officers shall serve one-year terms and shall serve until their successors are elected  
10 and qualified. No person shall chair the Commission for more than five consecutive years. The  
11 Commission may adopt rules governing the calling, holding, and conducting of regular and  
12 special meetings. A majority of Commission members present and voting constitutes a quorum,  
13 and no action may be taken without a quorum.

14 **"§ 90-750.4. Powers of the Commission.**

15 The Commission shall have the following powers and duties:

- 16 (1) Administer, coordinate, and enforce the provisions of this Article.
- 17 (2) Adopt, amend, or repeal rules necessary to conduct its business, carry out its  
18 duties, and administer this Article.
- 19 (3) Appoint and maintain advisory committees to fulfill the daily regulation of  
20 healing arts professions.
- 21 (4) Issue, renew, deny, suspend, or revoke Healing Arts Licenses, order  
22 probation, issue reprimands, and conduct any disciplinary actions authorized  
23 by this Article.
- 24 (5) Authorize expenditures deemed necessary to carry out the provisions of this  
25 Article from fees paid to the Commission pursuant to this Article.
- 26 (6) Remit to advisory committees funds sufficient for those advisory committees  
27 to carry out their duties.
- 28 (7) Conduct investigations for the purpose of discovering violations of this Article  
29 or grounds for disciplinary actions.
- 30 (8) Conduct any administrative hearings necessary for the administration of this  
31 Article, including disciplinary hearings to enforce the provisions of this  
32 Article.
- 33 (9) Establish fees as necessary for the administration of this Article.

34 **"§ 90-750.5. Expenses and fees.**

35 (a) All fees shall be payable to and deposited in the name of the Commission in financial  
36 institutions designated by the Commission as official depositories. These fees shall be used to  
37 carry out the purposes of this Article.

38 (b) All salaries, compensation, and expenses incurred or allowed to carry out the purposes  
39 of this Article shall be paid by the Commission exclusively out of the fees received by the  
40 Commission as authorized by this Article or funds received from other sources. In no case shall  
41 any salary, expense, or other obligation authorized by this Article be charged against the State  
42 treasury.

43 (c) The Commission shall establish fees for healing arts professions not exceeding the  
44 following amounts:

- 45 (1) Issuance of a North Carolina Healing Arts License..... \$300.00
- 46 (2) License application and examination..... \$200.00
- 47 (2) North Carolina Healing Arts License renewal (annually)..... \$350.00
- 48 (4) Late renewal ..... \$200.00.

49 **"§ 90-750.6. Violations.**

50 (a) Except as provided in subsection (b) of this section, any person violating any  
51 provision of this Article shall be punished as follows:

- (1) For the first violation, the individual shall receive a written warning.
- (2) For the second violation, the individual shall be subject to a civil penalty of no more than two hundred dollars (\$200.00).
- (3) For the third and each subsequent violation, the individual shall be subject to a civil penalty of no more than two hundred dollars (\$200.00) for each violation and shall be guilty of a Class 1 misdemeanor.

(b) Any person violating any provision of Part 4 of this Article shall be punished as a Class 1 misdemeanor.

(c) The clear proceeds of a civil penalty assessed under this section shall be remitted to the Civil Penalty and Forfeiture Fund in accordance with G.S. 115C-457.2.

**"§ 90-750.7. Injunction.**

As an additional remedy, the Commission may proceed in superior court to enjoin and restrain any person from violating the prohibitions of this Article. The Commission shall not be required to post bond when seeking an injunction pursuant to this section.

**"§ 90-750.8. Healing arts professions.**

The following are the healing arts professions subject to this Article:

- (1) Reflexologists.
- (2) Music therapists.
- (3) Naturopathic doctors.

"Part 2. Reflexology.

**"§ 90-750.10. Reflexology as a healing arts profession.**

It is the policy of this State that the practice of reflexology shall be considered a healing arts profession.

**"§ 90-750.11. Definitions.**

The following definitions apply in this Part:

- (1) Certifying entity. – The American Reflexology Certification Board or its successor.
- (2) Committee. – The North Carolina Reflexology Advisory Committee.
- (3) National certification. – A determination by the certifying entity that an individual has passed the certifying entity's national exam and that the individual has an active status with the certifying entity.
- (4) North Carolina Licensed Reflexologist. – An individual that (i) is certified by the certifying entity as a certified reflexologist and (ii) has been issued a North Carolina Healing Arts License in reflexology by the Commission.
- (5) Reflexology. – A protocol of manual techniques, including thumb- and finger-walking, hook and backup, and rotating-on-a-point, that are applied to specific reflex areas predominantly on the feet and hands and that stimulate the complex neural pathways linking body systems and support the body's efforts to function optimally. The practice of reflexology is not massage and bodywork therapy as defined in Article 36 of this Chapter.

**"§ 90-750.12. North Carolina Reflexology Advisory Committee.**

(a) Establishment. – The North Carolina Reflexology Advisory Committee is created. The Committee consists of three members serving staggered terms. The initial Committee members shall be appointed on or before January 1, 2025, as follows:

- (1) The Commission shall appoint from a list of names submitted by the North Carolina Reflexology Association or its successor two reflexologists eligible for licensure under this Article. One member shall serve an initial term of three years, and one member shall serve an initial term of two years.
- (2) The Commission shall appoint one public member who shall serve an initial term of one year.

1 Upon the expiration of the terms of the initial Committee members, each subsequent member  
2 shall be appointed for a term of three years. The term of a member shall begin on January 1 of  
3 each year. A member shall serve until the member's successor is appointed. No member shall  
4 serve on the Committee for more than two consecutive full terms.

5 (b) Qualifications. – The initial reflexologist appointees shall be citizens of the United  
6 States and North Carolina residents for at least two years prior to appointment, certified by the  
7 certifying entity as a reflexologist, and eligible to obtain a North Carolina Healing Arts License  
8 in reflexology under G.S. 90-750.14. Upon appointment, each initial reflexologist appointee shall  
9 immediately seek to obtain a North Carolina Healing Arts License in reflexology under this  
10 Article and shall remain in good standing with the Committee during the appointee's term.  
11 Subsequent reflexologist appointees shall be citizens of the United States, residents of North  
12 Carolina, North Carolina Licensed Reflexologists, and appointed by the Commission from a list  
13 of names supplied by the North Carolina Reflexology Association or its successor. Public  
14 members of the Committee shall not be:

15 (1) An agent or employee trained or experienced in the practice of reflexology.

16 (2) An agent or employee of a person engaged in the practice of reflexology.

17 (3) A member of a healing arts profession or a person enrolled in a program to  
18 become a member of a healing arts profession.

19 (4) A spouse of an individual licensed under this Article.

20 (5) Any person with significant financial interest in a health service or profession.

21 (c) Meetings. – The Committee shall elect annually a chair and other officers as it deems  
22 necessary to carry out the purposes of this Article. The Committee may hold additional meetings  
23 upon the call of the chair or any two Committee members. A majority of the Committee shall  
24 constitute a quorum.

25 (d) Compensation of Members; Expenses; Employees. – Members of the Committee  
26 shall receive no compensation for their services but shall receive per diem and necessary travel  
27 and subsistence expenses as provided in G.S. 138-5 and G.S. 138-6. In no event shall the State  
28 of North Carolina be liable for expenses incurred by the Committee in excess of the income  
29 derived from this Article.

30 **"§ 90-750.13. Powers and duties of Committee.**

31 The Committee shall have the following powers and duties:

32 (1) Administer and coordinate the provisions of this Part.

33 (2) Make recommendations to the Commission to adopt, amend, or repeal rules  
34 to administer and enforce this Part.

35 (3) Establish and determine qualification and fitness of applicants for a North  
36 Carolina Healing Arts License in reflexology under this Part.

37 (4) Make recommendations to the Commission to issue, renew, deny, suspend,  
38 revoke, or refuse to issue or renew a North Carolina Healing Arts License in  
39 reflexology under this Article.

40 (5) Make recommendations to the Commission to discipline North Carolina  
41 Licensed Reflexologists.

42 (6) Advise the Commission to seek civil and criminal penalties against  
43 nonlicensed individuals engaged in the practice of reflexology.

44 (7) Provide all North Carolina Licensed Reflexologists with a wallet-sized card  
45 identifying the bearer as a North Carolina Licensed Reflexologist.

46 (8) Maintain a list of all individuals in the State who hold a North Carolina  
47 Healing Arts License in reflexology.

48 **"§ 90-750.14. Healing arts licensure in reflexology application and requirements.**

49 Each individual desiring to obtain a North Carolina Healing Arts License in reflexology under  
50 this Article shall apply to the Committee in accordance with the procedures and rules prescribed  
51 by the Commission. The Committee shall recommend that the Commission issue a North

1 Carolina Healing Arts License in reflexology to any applicant who furnishes evidence  
2 satisfactory to the Committee that the applicant meets all of the following criteria:

- 3 (1) The applicant is at least 18 years of age.
- 4 (2) The applicant is of good moral character as determined by the Committee.
- 5 (3) The applicant holds a national certification issued by the certifying entity.
- 6 (4) The applicant has paid all applicable fees to the Commission as specified in  
7 G.S. 90-750.5.

8 **"§ 90-750.15. License renewal.**

9 Every North Carolina Healing Arts License in reflexology issued by the Commission shall  
10 be renewed on or before January 1 every year. The Committee shall recommend that the  
11 Commission renew the North Carolina Healing Arts License in reflexology of any individual  
12 who files a renewal application with the committee and who meets the criteria set forth in  
13 G.S. 90-750.14.

14 **"§ 90-750.16. Compensation for reflexology services; prohibited acts.**

15 (a) Compensation may be received for reflexology services only when those services are  
16 performed by an individual holding a North Carolina Healing Arts License in reflexology.  
17 Nonlicensed individuals who provide reflexology services or who engage in the practice of  
18 reflexology are subject to the penalties in G.S. 90-750.6 or an injunction under G.S. 90-750.7  
19 unless any of the following applies:

- 20 (1) The individual is a reflexology student working to obtain a certification of  
21 completion from a nationally recognized reflexology education program.
- 22 (2) The individual holds a certification of completion from a nationally  
23 recognized reflexology education program, and that program was completed  
24 no more than six months prior to that individual receiving compensation for  
25 reflexology services.

26 (b) Unless all reflexology services are performed by individuals holding a North Carolina  
27 Healing Arts License in reflexology, a place of business where reflexology services are offered  
28 for compensation shall be subject to a civil penalty of no more than five hundred dollars  
29 (\$500.00) for each violation and a suspension of any license to operate the business for no more  
30 than 90 days. The clear proceeds of the civil penalty assessed under this section shall be remitted  
31 to the Civil Penalty and Forfeiture Fund in accordance with G.S. 115C-457.2. The Commission  
32 shall enforce the provisions of this subsection.

33 **"§ 90-750.17. License to be displayed; advertising.**

34 (a) At all places of business in which compensated reflexology services are offered, a  
35 valid and up-to-date license for all individuals offering compensated reflexology services shall  
36 be displayed in a prominent place.

37 (b) All public advertising designed to attract clients for reflexology services shall identify  
38 that the services will be performed by an individual holding a North Carolina Healing Arts  
39 License in reflexology.

40 (c) No individual shall use the title "North Carolina Licensed Reflexologist" unless that  
41 individual holds a valid North Carolina Healing Arts License in reflexology issued by the  
42 Commission. Individuals holding themselves out as North Carolina Licensed Reflexologists shall  
43 carry the identification card described in G.S. 90-750.13(7) at all times when providing  
44 reflexology services. Individuals in violation of this subsection are subject to the penalties in  
45 G.S. 90-750.6 or an injunction under G.S. 90-750.7.

46 **"§ 90-750.18. Reciprocity.**

47 The Committee may recommend that the Commission grant, upon application and payment  
48 of proper fees, a North Carolina Healing Arts License in reflexology to a person who has been  
49 licensed or certified to practice reflexology in another state or territory of the United States whose  
50 standards of competency are substantially equivalent to the requirements for licensure provided  
51 in this Article.

1 **"§ 90-750.19. Exemptions.**

2 This Part shall not apply to an individual who may apply pressure to the reflex areas on the  
3 hands, feet, and outer ears in the regular course of that individual's work, so long as (i) the  
4 individual is licensed by this State as a massage and bodywork therapist, physician, chiropractor,  
5 acupuncturist, physical therapist, cosmetologist, registered nurse, or as a member of other  
6 professions licensed by the State and (ii) this application of pressure to the reflex areas on the  
7 hands, feet, and outer ears accounts for no more than twenty-five percent (25%) of that  
8 individual's work.

9 "Part 3. Music Therapy.

10 **"§ 90-750.20. Music therapy as a healing arts profession.**

11 It is the policy of this State that the practice of music therapy shall be considered a healing  
12 arts profession.

13 **"§ 90-750.21. Definitions.**

14 The following definitions apply in this Part:

- 15 (1) Certifying entity. – The Certification Board for Music Therapists or its  
16 successor.
- 17 (2) Committee. – The North Carolina Music Therapy Advisory Committee.
- 18 (3) Music therapy. – The clinical and evidence-based use of music interventions  
19 to accomplish individualized goals within a therapeutic relationship by a  
20 credentialed professional who has completed an approved music therapy  
21 program, including (i) assessment of a client's emotional, physical, and  
22 spiritual health; social functioning; communication abilities; and cognitive  
23 skills through the client's history and observation and interaction of the client  
24 in music and nonmusic settings, (ii) development and implementation of  
25 treatment plans, based on a client's assessed needs, using music interventions,  
26 including music improvisation, receptive music listening, song writing, lyric  
27 discussion, music and imagery, music performance, learning through music,  
28 and movement to music, and (iii) evaluation and documentation of the client's  
29 response to treatment.
- 30 (4) Music therapy services. – The provision of services to accomplish music  
31 therapy goals, including (i) conducting an individualized assessment for the  
32 purpose of collecting systematic, comprehensive, and accurate data necessary  
33 to determine the course of action subsequent to the individualized treatment  
34 plan, (ii) planning and developing the individualized music therapy treatment  
35 plan that identifies an individual's goals, objectives, and potential treatment  
36 intervention strategies, (iii) implementing the individualized music therapy  
37 treatment plan consistent with the individual's overall treatment program, (iv)  
38 systematically evaluating and comparing the individual's response to the  
39 individualized music therapy treatment plan and suggesting modifications, as  
40 appropriate, (v) developing a discharge plan in collaboration with the  
41 individual, the individual's family, treatment team, and other identified  
42 support networks, when appropriate, (vi) minimizing the impact of  
43 environmental constraints as a barrier to participation in least restrictive  
44 environments for individuals engaging in music therapy, (vii) collaborating  
45 with and educating the individual, family, caregiver, and others to foster an  
46 environment responsive to the developmental needs of the individual as  
47 addressed in music therapy, and (viii) consulting with groups, programs,  
48 organizations, or communities to improve accessibility to music therapy  
49 services.

1           (5)    National certification. – A determination by the certifying entity that an  
2           individual has satisfied the certifying entity's requirements and that the  
3           individual has an active status with the certifying entity.

4           (6)    North Carolina Licensed Music Therapist. – An individual who has been  
5           issued a North Carolina Healing Arts License in music therapy by the  
6           Commission.

7    **"§ 90-750.22. North Carolina Music Therapy Advisory Committee.**

8           (a)    Establishment. – The North Carolina Music Therapy Advisory Committee is created.  
9           The Committee consists of three members serving staggered terms. The initial Committee  
10          members shall be appointed on or before January 1, 2025, as follows:

11          (1)    The Commission shall appoint from a list of names submitted by the Music  
12          Therapy Association of North Carolina or its successor two music therapists  
13          eligible to obtain a North Carolina Healing Arts License in music therapy  
14          under this Article. One member shall serve an initial term of three years, and  
15          one member shall serve an initial term of two years.

16          (2)    The Commission shall appoint one public member who shall serve an initial  
17          term of one year.

18          Upon the expiration of the terms of the initial Committee members, each subsequent member

27          this Article and shall remain in good standing with the Committee during the appointee's term.  
28          Subsequent music therapist appointees shall be citizens of the United States, residents of North  
29          Carolina, North Carolina Licensed Music Therapists, and appointed by the Commission from a  
30          list of names supplied by the Music Therapy Association of North Carolina or its successor.  
31          Public members of the Committee shall not be:

32          (1)    An agent or employee trained or experienced in the practice of music therapy.

33          (2)    An agent or employee of a person engaged in the practice of music therapy.

34          (3)    A member of a healing arts profession or a person enrolled in a program to  
35          become a member of a healing arts profession.

36          (4)    A spouse of an individual licensed under this Article.

- 12          (8)    Maintain a list of all individuals in the State who hold a North Carolina  
13          Healing Arts License in music therapy.

14    **"§ 90-750.24. North Carolina Healing Arts License in music therapy requirements.**

15        Each individual desiring to obtain a North Carolina Healing Arts License in music therapy  
16        under this Article shall apply to the Committee in accordance with the procedures and rules  
17        prescribed by the Commission. The Committee shall recommend that the Commission issue a  
18        North Carolina Healing Arts License in music therapy to any applicant who furnishes evidence  
19        satisfactory to the Committee that the applicant meets all of the following criteria:

- 20           (1)    Is 18 years of age or older.
- 21           (2)    Is of good moral character as determined by the Committee.
- 22           (3)    Has successfully completed an academic program accredited by the American  
23           Music Therapy Association (AMTA) with at least a bachelor's degree  
24           majoring in music therapy from an accredited college or university.
- 25           (4)    Has successfully completed the certification examination offered by the  
26           certifying entity to become a Music Therapist-Board Certified (MT-BC).
- 27           (5)    Has successfully completed a minimum of 1,200 hours of clinical training  
28           with at least 180 hours in preinternship experiences and at least 900 hours in  
29           internship experiences. For purposes of this subdivision, the internship may  
30           be approved by an academic institution, the AMTA, or both.
- 31           (6)    Has paid all applicable fees to the Commission as specified under  
32           G.S. 90-750.5.

33    **"§ 90-750.25. License renewal.**

34        Every North Carolina Healing Arts License in music therapy issued by the Commission shall  
35        be renewed on or before January 1 every five years. The Committee shall recommend that the  
36        Commission renew the license of any individual who files a renewal application with the  
37        committee and who meets the licensure criteria set forth in G.S. 90-750.24.

38    **"§ 90-750.26. Compensation for music therapy services; prohibited acts.**

39        Compensation may be received for music therapy services only when those services are  
40        performed by an individual holding a North Carolina Healing Arts License in music therapy.  
41        Nonlicensed individuals who provide music therapy services or who engage in the practice of  
42        music therapy are subject to the penalties in G.S. 90-750.6 or an injunction under G.S. 90-750.7.

43    **"§ 90-750.27. North Carolina Licensed Music Therapist.**

44        No individual shall use the title "North Carolina Licensed Music Therapist" unless that  
45        individual holds a valid North Carolina Healing Arts License in music therapy issued by the  
46        Commission. Individuals holding themselves out as North Carolina Licensed Music Therapists  
47        shall carry the identification card described in G.S. 90-750.23(7) at all times when providing  
48        music therapy. Individuals in violation of this section are subject to the penalties in G.S. 90-750.6  
49        or an injunction under G.S. 90-750.7.

50    **"§ 90-750.28. Reciprocity.**

1 The Committee may recommend that the Commission grant, upon application and payment  
 2 of proper fees, a North Carolina Healing Arts License in music therapy to a person who has been  
 3 licensed or certified to practice music therapy in another state or territory of the United States  
 4 whose standards of competency are substantially equivalent to the requirements for licensure  
 5 provided in this Article.

6 "Part 4. Naturopathic Doctors.

7 "**§ 90-750.30. Naturopathic medicine as a healing arts profession.**

8 It is the policy of this State that the practice of naturopathic medicine shall be considered a  
 9 healing arts profession.

10 "**§ 90-750.31. Definitions.**

11 The following definitions apply in this Part:

- 12 (1) Approved program of naturopathic medicine. – A program that meets all of  
 13 the following conditions:
- 14 a. A program that provides graduate-level, full-time didactic and  
 15 supervised clinical training in naturopathic medicine that is accredited,  
 16 or has achieved candidacy status for accreditation, by the Council on  
 17 Naturopathic Medical Education or an equivalent federally recognized  
 18 accrediting body for the naturopathic medical profession recognized  
 19 by the Committee, or if the program existed prior to the existence of  
 20 the Council on Naturopathic Medical Education, the program must (i)  
 21 have provided graduate-level, full-time didactic and supervised  
 22 clinical training in naturopathic medicine for a duration of not less than  
 23 132 weeks and required completion within a period of not less than 35  
 24 months, (ii) be recognized as a reputable program by, and in good  
 25 standing with, the Committee, and (iii) if the program is still in  
 26 existence, be currently accredited, or have achieved candidacy status  
 27 for accreditation by the Council on Naturopathic Medical Education  
 28 or an equivalent federally recognized accrediting body for the  
 29 naturopathic medical profession recognized by the Committee.
- 30 b. A program that is offered by an institution of higher education that is  
 31 accredited by a regional or national institutional accrediting body  
 32 recognized by the United States Secretary of Education.
- 33 c. If the program is offered in the United States, a program that awards  
 34 the degree of Doctor of Naturopathy or Doctor of Naturopathic  
 35 Medicine. If the program is offered in Canada, a program that awards  
 36 the degree or diploma of Doctor of Naturopathy or Doctor of  
 37 Naturopathic Medicine and is offered by an institution of higher  
 38 education that has provincial approval for participation in  
 39 government-funded student aid programs.
- 40 d. A program that has been approved by the Committee to meet the  
 41 standards established by its rules.
- 42 (2) Committee. – The North Carolina Naturopathic Medicine Advisory  
 43 Committee.
- 44 (3) Council. – The Naturopathic Doctors Formulary Council.
- 45 (4) Criminal history. – A history of conviction, or of having pled guilty or no  
 46 contest to a State or federal crime, whether a misdemeanor or felony.
- 47 (5) Integrative medicine. – As defined in G.S. 90-1.1.
- 48 (6) Natural medicines. – Any herbal, nutritional, supplemental, homeopathic, or  
 49 other nonprescription remedies.
- 50 (7) Naturopathic medicine. – A system of natural health care that employs  
 51 diagnosis and treatment using diagnostic techniques and natural therapies for

1 the promotion, maintenance, and restoration of health and the prevention of  
2 disease, including all of the following:

3 a. The administration or provision of any of the following for preventive  
4 and therapeutic purposes: natural medicines, natural therapies, natural  
5 topical medicines, hydrotherapy, dietary therapy, and naturopathic  
6 physical medicine.

7 b. The use of diagnostic procedures, including physical and orificial  
8 examination, but excluding endoscopy, sigmoidoscopy, and  
9 colonoscopy.

10 c. The ordering, performing, and interpretation of laboratory tests and  
11 diagnostic imaging.

12 (8) Naturopathic physical medicine. – The manual use of massage, stretching,  
13 resistance, or naturopathic manipulation.

14 (9) North Carolina Licensed Naturopathic Doctor or naturopathic doctor. – An  
15 individual who has been issued a North Carolina Healing Arts License in  
16 naturopathic medicine by the Commission.

17 **§ 90-750.32. Practice of naturopathic medicine; scope of practice.**

18 (a) Practice of Naturopathic Medicine. – A naturopathic doctor is a licensed health care  
19 provider having the same responsibilities as other licensed or registered health care providers  
20 regarding public health laws, reportable diseases and conditions, communicable disease control  
21 and prevention, and the recording of vital statistics. In diagnosing and treating an individual, a  
22 naturopathic doctor may employ the following therapies:

23 (1) Dispense, administer, order, and advise the use of natural remedies derived  
24 from or substantially similar to molecular structure or function to natural  
25 sources for preventive and therapeutic purposes, including food, extracts of  
26 food, nutraceuticals, vitamins, minerals, amino acids, enzymes, botanicals and  
27 their extracts, homeopathic remedies prepared according to the Homeopathic  
28 Pharmacopoeia of the United States, and all dietary supplements and  
29 nonprescription drugs, as defined by the Federal Food, Drug, and Cosmetic  
30 Act, 21 U.S.C. § 301 et seq.

31 (2) Order and perform physical examinations and physiological function tests.

32 (3) Order, perform, and interpret laboratory tests, including performing waived  
33 tests, as defined by the United States Food and Drug Administration Clinical  
34 Laboratory Improvement Amendments of 1988 (CLIA), including obtaining  
35 specimens to access and treat disease.

36 (4) Order diagnostic imaging, including X ray, MRI, CT scan, ultrasound,  
37 mammogram, and bone densitometry. The scope of this subdivision excludes  
38 electrocardiograms, echocardiograms, electroencephalograms, and nuclear  
39 imaging.

40 (5) Perform hot or cold hydrotherapy, naturopathic physical medicine,  
41 electromagnetic therapy, and therapeutic exercise.

42 (6) Perform health education and health counseling, including dietary and  
43 lifestyle counseling.

44 (7) Utilize routes of administration for substances, including oral, nasal, auricular,  
45 ocular, rectal, vaginal, and transdermal.

46 (8) Perform care incidental to superficial lacerations and abrasions, including the  
47 application of topical and local anesthetics and antimicrobials.

48 (b) Prohibitions. – A naturopathic doctor may practice only within the scope of practice  
49 authorized in this Article. A naturopathic doctor may not practice as any other health care  
50 professional licensed or registered under another Article of this Chapter unless otherwise licensed

1 or registered by this State to do so. A naturopathic doctor may not perform any of the following  
2 functions unless otherwise licensed by this State to do so:

- 3 (1) Prescribe, dispense, or administer any prescription drug or controlled  
4 substance, except as authorized by this Article.
- 5 (2) Use general or spinal anesthetics.
- 6 (3) Perform surgical procedures.
- 7 (4) Administer ionizing radioactive substances for therapeutic purposes.
- 8 (5) Child delivery.
- 9 (6) Diagnose and treat cancer. This prohibition does not apply to adjunctive or  
10 complementary care of patients who have previously been or are currently  
11 diagnosed with cancer.

12 **"§ 90-750.33. North Carolina Licensed Naturopathic Doctor; license required; exemptions.**

13 (a) No individual shall practice, attempt to practice, or claim to practice naturopathic  
14 medicine unless the person has been licensed under the provisions of this Article.

15 (b) Only an individual licensed under this Article may use the titles "Naturopathic  
16 Doctor," "Doctor of Naturopathic Medicine," "Doctor of Naturopathy," "Naturopathic  
17 Medicine," "Naturopath," "Licensed Naturopathic Doctor," or the abbreviations "N.D." or "ND,"  
18 or any other titles, words, letters, abbreviations, or insignia indicating or implying that the  
19 individual is a licensed naturopathic doctor unless the individual has been licensed as a  
20 naturopathic doctor under this Article.

21 (c) Exemptions. – Nothing in this Part shall be construed to prohibit or affect any of the  
22 following:

- 23 (1) The practice of a profession by an individual who is licensed or registered  
24 under other laws of this State and is performing services within the authorized  
25 scope of practice.
- 26 (2) The practice of naturopathic medicine by an individual employed by the  
27 federal government while the person is engaged in the performance of duties  
28 prescribed by laws and regulations of the United States.
- 29 (3) A person rendering aid in an emergency situation when no fee or other  
30 compensation for the service is received.
- 31 (4) The practice of naturopathic medicine by an individual duly licensed or  
32 registered in another state, territory, or the District of Columbia when called  
33 into this State to consult with a licensed or registered health care provider for  
34 a period not to exceed six months.
- 35 (5) The practice of naturopathic medicine by students completing a clinical  
36 requirement for graduation from an approved program of naturopathic  
37 medicine, so long as the practice is performed under the supervision of a  
38 physician licensed under Article 1 of this Chapter or a naturopathic doctor  
39 licensed under this Article and the clinical requirement does not exceed one  
40 year.
- 41 (6) A person who does not hold himself or herself out to be a naturopathic doctor  
42 when furnishing information to customers or selling, administering, or  
43 utilizing nutritional supplements, herbs, food, homeopathic preparations, and  
44 such physical forces as heat, cold, water, touch, and light at the person's retail,  
45 health spa, or health consulting establishment.

46 **"§ 90-750.34. North Carolina Naturopathic Medicine Advisory Committee.**

47 (a) Establishment. – The North Carolina Naturopathic Medicine Advisory Committee is  
48 created. The Committee consists of three members serving staggered terms. The initial  
49 Committee members shall be appointed on or before January 1, 2025, as follows:

- 50 (1) The Commission shall appoint from a list of names submitted by the North  
51 Carolina Association of Naturopathic Physicians or its successor two

1 naturopathic doctors eligible to obtain a North Carolina Healing Arts License  
2 in naturopathic medicine under this Article. One member shall serve an initial  
3 term of three years, and one member shall serve an initial term of two years.

4 (2) The Commission shall appoint one public member who shall serve an initial  
5 term of one year.

6 Upon the expiration of the terms of the initial Committee members, each subsequent member  
7 shall be appointed for a term of three years. The term of a member shall begin on January 1 of  
8 each year. A member shall serve until the member's successor is appointed. No member shall  
9 serve on the Committee for more than two consecutive full terms.

10 (b) Qualifications. – The initial naturopathic doctor appointees shall be citizens of the  
11 United States and North Carolina residents for at least two years prior to appointment, graduates  
12 of an approved program of naturopathic medicine, and eligible to obtain a North Carolina Healing  
13 Arts License in naturopathic medicine under G.S. 90-750.37. Upon appointment, each initial  
14 naturopathic doctor appointee shall immediately seek to obtain a North Carolina Healing Arts  
15 License in naturopathic medicine under this Article and shall remain in good standing with the  
16 Committee during the appointee's term. Subsequent naturopathic doctor appointees shall be  
17 citizens of the United States, residents of North Carolina, North Carolina Licensed Naturopathic  
18 Doctors, and appointed by the Commission from a list of names supplied by the North Carolina  
19 Association of Naturopathic Physicians or its successor. Public members of the Committee shall  
20 not be:

21 (1) An agent or employee trained or experienced in the practice of naturopathic  
22 medicine.

23 (2) An agent or employee of a person engaged in the practice of naturopathic  
24 medicine.

25 (3) A member of a healing arts profession or a person enrolled in a program to  
26 become a member of a healing arts profession.

27 (4) A spouse of an individual licensed under this Article.

28 (5) Any person with significant financial interest in a health service or profession.

29 (c) Meetings. – The Committee shall elect annually a chair and other officers as it deems  
30 necessary to carry out the purposes of this Article. The Committee may hold additional meetings  
31 upon the call of the chair or any two Committee members. A majority of the Committee shall  
32 constitute a quorum.

33 (d) Compensation of Members; Expenses; Employees. – Members of the Committee  
34 shall receive no compensation for their services but shall receive per diem and necessary travel  
35 and subsistence expenses as provided in G.S. 138-5 and G.S. 138-6. In no event shall the State  
36 of North Carolina be liable for expenses incurred by the Committee in excess of the income  
37 derived from this Article.

38 **"§ 90-750.35. Powers and duties of Committee.**

39 The Committee shall have the following powers and duties:

40 (1) Administer and coordinate the provisions of this Part.

41 (2) Make recommendations to the Commission to adopt, amend, or repeal rules  
42 to administer and enforce this Part, including rules for approved continuing  
43 education.

44 (3) Establish and determine qualification and fitness of applicants for a North  
45 Carolina Healing Arts License in naturopathic medicine under this Part.

46 (4) Make recommendations to the Commission to issue, renew, deny, suspend,  
47 revoke, or refuse to issue or renew a North Carolina Healing Arts License in  
48 naturopathic medicine under this Article.

49 (5) Make recommendations to the Commission to discipline North Carolina  
50 Licensed Naturopathic Doctors.

- 1           (6) Advise the Commission to seek civil and criminal penalties against  
2 nonlicensed individuals engaged in the practice of naturopathic medicine.  
3           (7) Maintain a list of all naturopathic doctors in the State who hold a North  
4 Carolina Healing Arts License in naturopathic medicine.  
5           (8) Make recommendations to the Commission to adopt a formulary based on the  
6 recommendations of the Council made under G.S. 90-750.36. The Committee  
7 may modify or reject any recommendation of the Council regarding the  
8 formulary.

9 **"§ 90-750.36. Naturopathic Doctors Formulary Council.**

10       (a) Composition and Terms. – The Naturopathic Doctors Formulary Council is formed  
11 within and appointed by the Committee and exists under the supervision of the Committee. The  
12 Council shall develop and recommend to the Committee, on an ongoing basis, a formulary for  
13 naturopathic doctors to use in practice.

14           (1) The Council consists of the following members:

- 15           a. Two naturopathic doctors who (i) hold a North Carolina Healing Arts  
16 License in naturopathic medicine, (ii) practice naturopathic medicine  
17 in North Carolina, (iii) have a minimum of two years of experience  
18 practicing naturopathic medicine, and (iv) have resided in North  
19 Carolina for at least two years prior to appointment.  
20           b. One physician licensed under Article 1 of Chapter 90 of the General  
21 Statutes who is involved in the practice of integrative medicine or  
22 teaches integrative medicine at a medical school and practices in the  
23 State.  
24           c. One physician licensed under Article 1 of Chapter 90 of the General  
25 Statutes who practices in the State.  
26           d. One pharmacist who has a background in pharmacognosy and who  
27 practices in the State.  
28           e. One member of the public who is not a licensed or registered health  
29 care professional and is not employed in a health care profession and  
30 resides in this State.

31           (2) Members appointed under subdivision (1) of this subsection shall serve for a  
32 term of three years and shall continue to serve after the expiration of the term  
33 until a successor is appointed by the Committee.

34       (b) Powers and Duties. – The Council shall have the following powers and duties:

- 35           (1) Develop and recommend to the Committee a formulary for use by licensed  
36 naturopathic doctors.  
37           (2) Review, annually and at the discretion of the Committee, the formulary  
38 adopted by the Commission to determine whether any changes are necessary  
39 for compliance with current prescribing standards or the practice of  
40 naturopathic standards.  
41           (3) Recommend to the Committee any changes that, in the Council's discretion,  
42 need to be implemented to improve the formulary.

43       (c) The formulary recommended to the Committee by the Council shall include natural  
44 remedies that may require a prescription or a remedy derived from or substantially similar in  
45 molecular structure or function to natural sources that may require a prescription. Substances  
46 included in the formulary must be allowed within the scope of practice and should be protected  
47 within the future scope of practice for naturopathic doctors.

48       (d) The Committee shall designate the chair of the Council and shall provide staff  
49 necessary to carry out the Council's powers and duties.

50       (e) A Council member may not receive compensation but may receive reimbursement,  
51 as provided in G.S. 93B-5.

1 **"§ 90-750.37. North Carolina Healing Arts License in naturopathic medicine requirements.**

2 Each individual desiring to obtain a North Carolina Healing Arts License in naturopathic  
3 medicine under this Article shall apply to the Committee in accordance with the procedures and  
4 rules prescribed by the Commission. The Committee shall recommend that the Commission issue  
5 a North Carolina Healing Arts License in naturopathic medicine to any applicant who furnishes  
6 evidence satisfactory to the Committee that the applicant meets all of the following criteria:

- 7 (1) Is 18 years of age or older.
- 8 (2) Is of good moral and ethical character as determined by the Committee.
- 9 (3) Has graduated from an approved program of naturopathic medicine as defined  
10 in G.S. 90-750.31.
- 11 (4) Meets either of the following two conditions:
- 12 a. Has successfully passed the Naturopathic Physicians Licensing  
13 Examination (NPLEX), a competency-based national naturopathic  
14 licensing examination administered by the North American Board of  
15 Naturopathic Examiners or an equivalent successor agency recognized  
16 by the Committee.
- 17 b. Has successfully passed a competency-based state or Canadian  
18 province naturopathic licensing examination administered prior to the  
19 existence of NPLEX and approved by the Committee.
- 20 (5) Has submitted to the Committee a written attestation that is approved by the  
21 Committee and that complies with all of the following criteria:
- 22 a. The applicant attests to having a collaboration and consultation  
23 agreement with a physician licensed under Article 1 of Chapter 90 of  
24 the General Statutes and provides the name and license number of the  
25 physician identified in the collaboration and consultation agreement.
- 26 b. An attestation that the physician has been informed of the  
27 collaboration and consultation agreement.
- 28 c. The applicant attests to refer patients to physicians and to consult with  
29 physicians and other health care providers licensed or registered in this  
30 State.
- 31 d. The applicant attests that the collaboration and consultation agreement  
32 does not require or implement supervision of the applicant by the  
33 physician or health care professional identified in the collaboration or  
34 consultation agreement.
- 35 (6) Has submitted to any criminal history record check required by the  
36 Commission. The Committee is responsible for providing to the North  
37 Carolina Department of Justice the fingerprints of the person to be checked, a  
38 form signed by the person consenting to the criminal record check and the use  
39 of fingerprints and other identifying information required by the State or  
40 national repositories, and any additional information required by the  
41 Department of Justice. The Committee and Commission shall keep all  
42 information obtained pursuant to this section confidential. If a criminal history  
43 record check reveals one or more convictions, the conviction does not  
44 automatically bar licensure, in accordance with Chapter 93B of the General  
45 Statutes. The Committee shall consider all of the following factors regarding  
46 the conviction:
- 47 a. The level of seriousness of the crime.
- 48 b. The date of the crime.
- 49 c. The age of the person at the time of the conviction.
- 50 d. The circumstances surrounding the commission of the crime, if  
51 known.

- 1           e.     The nexus between the criminal conduct of the person and the job  
2                 duties of the position to be filled.  
3           f.     The person's prison, jail, probation, parole, rehabilitation, and  
4                 employment records since the date the crime was committed.  
5           g.     The subsequent commission of a crime by the person.  
6           h.     Any additional criteria specified in G.S. 93B-8.1.

7           (7)    Has submitted to the Committee any other documentation the Committee  
8                 deems necessary to determine the applicant's fitness for licensure under this  
9                 Article. This documentation may include successful completion of a  
10                Committee-approved jurisprudence examination on State laws and rules  
11                related to naturopathic medicine.

12          (8)    Has paid all applicable fees to the Commission as specified under  
13                 G.S. 90-750.5.

14    **"§ 90-750.38. License renewal and reinstatement.**

15          (a)    Renewal. – Every North Carolina Healing Arts License in naturopathic medicine  
16                 issued by the Commission shall be renewed on or before January 1 every year. The Committee  
17                 shall recommend that the Commission renew the license of any individual who files a renewal  
18                 application with the Committee, meets the licensure criteria set forth in G.S. 90-750.37, and has  
19                 completed at least 20 hours of continuing education approved by the Committee within the  
20                 one-year period immediately prior to the renewal date.

21          (b)    Reinstatement. – An individual who held a North Carolina Healing Arts License in  
22                 naturopathic medicine who has allowed the license to lapse by failure to renew within the time  
23                 allowed under subsection (a) of this section may apply for reinstatement. The Committee may  
24                 recommend reinstatement of the applicant's license if the applicant pays the required fees,  
25                 furnishes a statement of the reason for failure to apply for renewal before the deadline, and  
26                 complies with any other requirements established in rules adopted by the Commission. If the  
27                 license has lapsed for five years or longer, the Committee may recommend that the Commission  
28                 require the applicant to satisfactorily complete one or more skills assessment or remediation  
29                 courses approved by the Commission or to provide proof of active licensure, or registration  
30                 within the past five years in another state, district, territory, or Canadian province.

31    **"§ 90-750.39. Reciprocity.**

32          The Committee may recommend the Commission issue, upon application and payment of  
33                 fees, a North Carolina Healing Arts License in naturopathic medicine to a person who resides in  
34                 this State and is actively licensed or registered to practice naturopathic medicine in another state,  
35                 district, territory, or Canadian province, if both of the following conditions are met:

36           (1)    The standards for licensure or registration in the state, district, territory, or  
37                 province in which the person is actively licensed or registered to practice  
38                 naturopathic medicine are substantially equivalent to those provided in this  
39                 Article.

40           (2)    The applicant provides proof of licensure or registration in good standing in  
41                 all states, districts, territories, and provinces in which the applicant has been  
42                 licensed or registered.

43    **"§ 90-750.40. Reports; immunity from suit.**

44          (a)    Report. – A person who has reasonable cause to suspect misconduct or incapacity of  
45                 a North Carolina Licensed Naturopathic Doctor, or who has reasonable cause to suspect that a  
46                 person is in violation of this Part, may report the relevant facts to the Committee. Upon receipt  
47                 of a charge, the Committee shall recommend that the Commission investigate the charge and  
48                 take appropriate action, including discipline, if necessary. Upon receipt of a charge, the  
49                 Commission may give notice of an administrative hearing or may, after diligent investigation,  
50                 dismiss unfounded charges. A person who, in good faith, makes a report pursuant to this section  
51                 is immune from any criminal prosecution or civil liability resulting from making the report.



1       (b) Limited Immunity. – Both the Commission and the Committee, including their  
2 officers, employees, and staff, are immune from any criminal prosecution or civil liability for  
3 exercising, in good faith, the powers and duties given under this Article.

4 **"§ 90-750.41. Third-party reimbursement.**

5       Nothing in this Article shall be construed to require direct third-party reimbursement to  
6 persons licensed under this Article."

7       **SECTION 1.(b)** G.S. 90-18(c) reads as rewritten:

20 **PROHIBIT THE ACQUISITION OF QUARTZ MINING OPERATIONS AND LANDS**  
21 **CONTAINING HIGH PURITY QUARTZ BY FOREIGN GOVERNMENTS**  
22 **DESIGNATED AS ADVERSARIAL BY THE UNITED STATES DEPARTMENT OF**  
23 **COMMERCE**

24 **SECTION 10.(a)** Chapter 64 of the General Statutes is amended by adding a new  
25 Article to read:

26 "Article 3.

27 "Prohibit Adversarial Foreign Government Acquisition of High Purity Quartz.

28 **"§ 64-50. Title.**

29 This act shall be known and be cited as the North Carolina High Purity Quartz Protection  
30 Act.

31 **"§ 64-51. Purpose.**

32 The General Assembly finds that high purity quartz is a highly valuable resource used in the  
33 manufacture of semiconductors, optical fibers, circuit boards, and other technologically advanced  
34 components and it is therefore in the public interest for the State to guard its deposits of high  
35 purity quartz from the potential of adversarial foreign government control in order to protect our  
36 vital mineral and economic resources.

37 **"§ 64-52. Definitions.**

38 As used in this Article, the following definitions apply:

39 (1) Adversarial foreign government. – A state-controlled enterprise or the  
40 government of a foreign nation that has received a designation under 15 C.F.R.  
41 § 7.4 from a determination by the United States Secretary of Commerce that  
42 the entity has engaged in a long-term pattern or serious instances of conduct  
43 significantly adverse to the national security of the United States or security  
44 and safety of United States persons.

45 (2) Controlling interest. – Possession of more than fifty percent (50%) of the  
46 ownership interest in an entity. The term also includes possession of fifty  
47 percent (50%) or less of the ownership interest in an entity if an owner directs  
48 the business and affairs of the entity without the requirement or consent of any  
49 other party.

50 (3) High purity quartz. – A mineral made of silicon dioxide and containing fewer  
51 than 50 parts per million of impurity elements.



(4) Interest. – Any estate, remainder, or reversion, or any portion of the estate, remainder, or reversion, or an option pursuant to which one party has a right to cause the transfer of legal or equitable title to land covered by G.S. 64-53(a); or ownership or partial ownership of a mining operation covered under G.S. 64-53(a).

(5) State-controlled enterprise. – A business enterprise, however denominated, in which a foreign government has a controlling interest.

**"§ 64-53. Adversarial foreign government acquisition of high purity quartz resources prohibited.**

(a) Notwithstanding any provision of law to the contrary, no adversarial foreign government shall purchase, acquire, lease, or hold any interest in the following:

(1) A quartz mining operation.

(2) Land containing commercially valuable amounts of high purity quartz.

(b) Any transfer of an interest in land or a mining operation in violation of this section shall be void.

(c) The responsibility for determining whether an individual or other entity is subject to this Article rests solely with the United States Secretary of Commerce and the State of North Carolina and no other individual or entity. An individual or other entity who is not an adversarial foreign government shall bear no civil or criminal liability for failing to determine or make inquiry of whether an individual or other entity is an adversarial foreign government."

**SECTION 10.(b)** This section is effective when it becomes law and applies only to ownership interests acquired on and after that date.

**EXPAND REQUIREMENTS FOR ISSUANCE OF 401 CERTIFICATIONS BY THE DEPARTMENT OF ENVIRONMENTAL QUALITY TO PROJECTS LOCATED AT AN EXISTING OR FORMER ELECTRIC GENERATING FACILITY**

**SECTION 11.(a)** G.S. 143-214.1A reads as rewritten:

**"§ 143-214.1A. Water quality certification requirements for certain projects.**

(a) The following requirements shall govern applications for certification filed with the Department pursuant to section 401 of the Clean Water Act, 33 U.S.C. § 1341(a)(1), for maintenance dredging projects partially funded by the Shallow Draft Navigation Channel Dredging and Aquatic Weed Fund-Fund, electric generation projects located at an existing or former electric generating facility, and projects involving the distribution or transmission of energy or fuel, including natural gas, diesel, petroleum, or electricity:

...."

**SECTION 11.(b)** This section is effective when it becomes law and applies to applications for 401 Certification pending or submitted on or after that date.

**PROHIBIT PUBLIC WATER AND SEWER SYSTEMS FROM IMPOSING UNAUTHORIZED CONDITIONS AND IMPLEMENTING PREFERENCE SYSTEMS FOR ALLOCATING SERVICE TO RESIDENTIAL DEVELOPMENT**

**SECTION 12.(a)** Chapter 162A of the General Statutes is amended by adding a new Article to read:

"Article 11.

"Miscellaneous.

**"§ 162A-900. Limitations on allocating service for residential development.**

(a) For purposes of this section, "residential development" means new development of single-family or multifamily housing.

(b) A local government unit, as defined in G.S. 162A-201, shall not require an applicant for water or sewer service for residential development to agree to any condition not otherwise

1 authorized by law, or to accept any offer by the applicant to consent to any condition not  
 2 otherwise authorized by law. These conditions include, without limitation, any of the following:

- 3 (1) Payment of taxes, impact fees or other fees, or contributions to any fund.  
 4 (2) Adherence to any restrictions related to land development or land use,  
 5 including those within the scope of G.S. 160D-702(c).  
 6 (3) Adherence to any restrictions related to building design elements within the  
 7 scope of G.S. 160D-702(b).

8 (c) A local government unit, as defined in G.S. 162A-201, shall not implement a scoring  
 9 or preference system to allocate water or sewer service among applicants for water or sewer  
 10 service for residential development that does any of the following:

- 11 (1) Includes consideration of building design elements, as defined in  
 12 G.S. 160D-702(b).  
 13 (2) Sets a minimum square footage of any structures subject to regulation under  
 14 the North Carolina Residential Code.  
 15 (3) Requires a parking space to be larger than 9 feet wide by 20 feet long unless  
 16 the parking space is designated for handicap, parallel, or diagonal parking.  
 17 (4) Requires additional fire apparatus access roads into developments of one- or  
 18 two-family dwellings that are not in compliance with the required number of  
 19 fire apparatus access roads into developments of one- or two-family dwellings  
 20 set forth in the Fire Code of the North Carolina Residential Code."

21 **SECTION 12.(b)** This section is effective when it becomes law.

 36 overrecovery by credit to bill or through a decrement in its rates and shall permit the utility to  
 37 recover any deficiency through an increment in its rates. If the Commission finds the  
 38 overrecovery or deficiency has been or is likely to be substantially reduced, negated, or reversed  
 39 before or during the period in which it would be credited or recovered, the Commission, in its  
 40 discretion, may order the utility to make an appropriate adjustment or no adjustment to its rates,  
 41 consistent with the public interest.

43 (d1) The utility shall not recover from ratepayers, in any rate recovery proceeding or rider,  
 44 the incremental cost of natural gas attributable to renewable energy biomass resources that  
 45 exceeds the average system cost of gas unattributable to renewable energy biomass resources  
 46 calculated and filed with the Commission pursuant to subsection (c) of this section. Each natural  
 47 gas local distribution company that incurs costs attributable to renewable energy biomass  
 48 resources shall submit the utility's actual cost thereof to the Commission monthly for purposes  
 49 of determining the total amount of natural gas costs recoverable under this section.

50 ~~(e) As used in this section, the word "cost" or "costs" shall be defined by Commission~~  
 51 ~~rule or order and may include all costs related to the purchase and transportation of natural gas~~

1 to the natural gas local distribution company's system. The following definitions apply in this  
2 section:

- 3 (1) "Cost" or "costs" shall be defined by Commission rule or order and may

14 wastewater."

8                   application for a pass included within the Annual Pass Program and (ii) has  
9                   provided the Division a copy of the veteran's disability certification or  
10                  evidence of benefits received under 38 U.S.C. § 2101.

11                  **SECTION 15.(b)** Fee Exemption. – An Eligible Disabled Veteran whose application  
12                  under this section has been approved by the Division shall not be required to pay a fee for any  
13                  pass included within the Annual Pass Program.

14                  **SECTION 15.(c)** Application Required. – A Disabled Veteran seeking a pass under  
15                  the Annual Pass Program shall apply for the pass on a form and in a manner prescribed by the  
16                  Division.

17                  **SECTION 15.(d)** Rulemaking. – The Department of Natural and Cultural Resources  
18                  shall adopt rules, or amend any current rules, necessary to implement this section.

24                  15A NCAC Subchapter 07H (State Guidelines for Areas of Environmental Concern).

25                  **SECTION 16.(b)** CAMA Rules. – Until the effective date of the revised permanent  
26                  rules that the Coastal Resources Commission is required to adopt pursuant to subsection (d) of  
27                  this section, the Commission shall implement the CAMA Rules as provided in subsection (c) of  
28                  this section.

29                  **SECTION 16.(c)** Implementation. – Notwithstanding any provision of Subchapter  
30                  7H of Title 15A of the North Carolina Administrative Code, the Coastal Resources Commission  
31                  shall, for the purpose of a dune building and beach planting project, authorize local governments  
32                  that have received a permit to construct a terminal groin pursuant to G.S. 113A-115.1 to establish  
33                  a measurement line, as that term is defined under 15A NCAC 07H .0305(9), that represents the  
34                  location of the first line of stable and natural vegetation that is covered by the dune building and  
35                  beach planting project. The measurement line shall be: (i) established in coordination with the  
36                  Division of Coastal Management using on-ground observation and survey or aerial imagery for  
37                  all areas of oceanfront that undergo dune building and beach planting project; and (ii) applicable  
38                  for a period of no less than two years from the completion of the dune building and beach planting  
39                  project.

40                  **SECTION 16.(d)** Additional Rulemaking Authority. – The Commission shall adopt

28 **SECTION 18.** G.S. 130A-248(c2) reads as rewritten:

29 "(c2) Notwithstanding any provision of this Part, a food establishment may use an outdoor  
30 grill to prepare food for customers for sample or sale if all of the following criteria are met:

31 (1) The outdoor grill is located on the premises of the food establishment and is  
32 continuously supervised by a food employee when the grill is in use.

33 (2) The outdoor grill has a cooking surface made of stainless steel ~~or cast iron,~~  
34 cast iron, stone, or similar surface that complies with Parts 4-1 and 4-2 of the  
35 NC Food Code and meets sanitation requirements for equipment in a food  
36 establishment, and is stationed on a concrete or asphalt foundation.

37 (3) The outdoor grill is not operated within 10 feet of combustible construction.

38 (4) All open food and utensils are provided with overhead protection or otherwise  
39 equipped with individual covers, such as domes, chafing lids, or cookers with  
40 hinged lids.

41 (5) The outdoor grill is ~~located in an enclosed area and~~ protected from  
42 environmental contamination when not in operation.

43 (6) The outdoor grill and concrete or asphalt foundation are cleaned daily on any  
44 day that the grill is in operation.

45 (7) Raw meat, poultry, and fish are prepared in a pre-portioned or ready-to-cook  
46 form inside the food establishment and may only be handled indirectly with  
47 utensils when using the outdoor grill. Food prepared on the outdoor grill is  
48 processed inside the food establishment."  
49

1 **CLARIFY MINIMUM AGE FOR ESCORT VEHICLE DRIVERS, ALLOW THIRD**  
2 **PARTY TRAINING AND CERTIFICATION, AND CREATE ADDITIONAL**  
3 **REQUIREMENTS FOR ESCORT VEHICLES**

4 **SECTION 19.** G.S. 20-119(f) reads as rewritten:

5 "(f) The Department of Transportation shall issue rules to establish an escort driver  
6 training and certification program for escort vehicles accompanying oversize/overweight loads.  
7 Department issued eligibility requirements for escort driver training and certification shall not  
8 include a minimum age for an escort driver greater than 18 years of age or that the applicant  
9 possess a commercial drivers license. A person that possesses a valid Class A commercial drivers  
10 license may sit for an escort vehicle certification examination without meeting any additional  
11 education or training requirements. Any driver operating a vehicle escorting an  
12 oversize/overweight load shall meet any training requirements and obtain certification under the  
13 rules issued pursuant to this subsection. These rules may provide for reciprocity with other states  
14 having similar escort certification programs. The Department shall allow third parties, including  
15 employers of escort drivers, to train and certify escort drivers pursuant to the rules issued by the  
16 Department to implement this subsection. Certification credentials for the driver of an escort  
17 vehicle shall be carried in the vehicle and be readily available for inspection by law enforcement  
18 personnel. The escort and training certification requirements of this subsection shall not apply to  
19 the transportation of agricultural machinery until October 1, 2004. The Department of  
20 Transportation shall develop and implement an in-house training program for agricultural  
21 machinery escorts by September 1, 2004. A motor vehicle intended to be used as an escort vehicle  
22 must meet all of the following requirements:

- 23 (1) Meets all legal requirements for travel on a roadway in the State of North  
24 Carolina.  
25 (2) Is a single motor vehicle with a GVWR of at least 2,000 pounds and not more  
26 than 26,000 pounds.  
27 (3) Is not transporting hazardous materials while being used as an escort vehicle.  
28 (4) Is not pulling a trailer while being used as an escort vehicle.  
29 (5) Is equipped with lighting that is visible from all directions."  
30

31 **CLARIFY LIABILITY FOR MISMARKEED UNDERGROUND FACILITIES**

32 **SECTION 20.** G.S. 87-128 reads as rewritten:

34 If an operator who has been given notice as provided in G.S. 87-120(d) by the Notification

40 of those facilities near the proposed excavation area. If the operator has visited the proposed  
41 excavation or demolition area and failed to properly locate a facility, there shall be a presumption,  
42 rebuttable by clear and convincing evidence, that the excavator has exercised due care, regardless  
43 of the presence of visible indications of a facility at the proposed excavation or demolition area,  
44 such as a pole, marker, pedestal, meter, or valve. For purposes of this section, a facility is not  
45 properly located if the marks are placed outside of the tolerance zone of the existing facility's  
46 actual location."

18 newspapers having general circulation in the taxing unit. A tax collector shall, in addition to the  
19 advertisements required by this section, also advertise a tax lien by posting a notice of the lien in  
20 a conspicuous manner at the parcel to be advertised. Advertisements of tax liens shall be made  
21 during the period March 1 through June 30. The costs of newspaper advertising shall be paid by  
22 the taxing unit. If the taxes of two or more taxing units are collected by the same tax collector,  
23 the tax liens of each unit shall be advertised separately unless, under the provisions of a special  
24 act or contractual agreement between the taxing units, joint advertisement is permitted.

#### 35 "§ 160D-970. Advanced air mobility radar.

36 (a) A local government may plan for and regulate the siting, installation, modification,  
37 maintenance, and removal of advanced air mobility radar for traffic control of unmanned aircraft  
38 systems flown in accordance with Article 10 of Chapter 63 of the General Statutes.

39 (b) Nothing contained in this Part shall amend, modify, or otherwise affect any easement  
40 between private parties. Any and all rights for the use of a right-of-way are subject to the rights  
41 granted pursuant to an easement between private parties.

42 (c) A local government may require a permit applicant to remove abandoned advanced  
43 air mobility radar within 180 days of abandonment. If not timely removed, the local government  
44 may remove the abandoned advanced air mobility radar and may recover the actual cost of such  
45 removal, including legal fees, if any, from the permit applicant.

46 (d) Nothing in this Part shall be construed to limit the provisions or requirements of any  
47 historic district or landmark regulation adopted pursuant to this Chapter.

#### 48 "§ 160D-971. Definitions.

49 For purposes of this Part, the following definitions shall apply:

50 (1) Advanced air mobility radar. – A system for detecting the presence, direction,  
51 distance, and speed of unmanned electrical aircraft or electric vertical take-off

1 and landing aircraft, in both controlled and uncontrolled airspace, by sending  
2 out pulses of high-frequency electromagnetic waves that are reflected off the  
3 object back to the source that supports a transportation system of unmanned  
4 electrical aircraft or electric vertical take-off and landing aircraft.

5 (2) Collocation. – The placement, installation, maintenance, modification,  
6 operation, or replacement of advanced air mobility radar on the surface of  
7 existing structures, including water towers, buildings, and other structures  
8 capable of structurally supporting the attachment of advanced air mobility  
9 radar in compliance with applicable codes. The term does not include the  
10 installation or construction of new structures.

11 (3) Permit applicant. – A North Carolina nonprofit corporation with a certificate  
12 of existence under G.S. 55A-1-28 with the primary purpose of promotion and  
13 growth of advanced air mobility technology in this State.

14 (4) Water tower. – A water storage tank, a standpipe, or an elevated tank situated  
15 on a support structure originally constructed for use as a reservoir or facility  
16 to store or deliver water.

17 **§ 160D-972. Siting and construction of advanced air mobility radar.**

18 (a) A permit applicant that proposes to construct advanced air mobility radar within the  
19 planning and development regulation jurisdiction of a local government shall do all of the  
20 following:

21 (1) Submit a completed application with the necessary copies and attachments to  
22 the local government, including documentation of any collocation agreement.

23 (2) Comply with all development regulations.

24 (3) Obtain all applicable development approvals.

25 (b) A local government shall not assess a fee for the application for, or the installation  
26 and use of, advanced air mobility radar provided the advanced air mobility radar is installed and  
27 operated in compliance with the standards and requirements set forth in this Part.

28 (c) In reviewing an application, the local government may review the following:

29 (1) Applicable public safety and development regulations, including aesthetics,  
30 landscaping, land-use based location priorities, structural design, setbacks,  
31 and fall zones.

32 (2) Information or materials directly related to an identified public safety or  
33 development regulation.

34 (3) If a collocation agreement is not included with the completed application, a  
35 local government may require permit applicants to evaluate the reasonable  
36 feasibility of collocation, including information necessary for the local  
37 government to determine whether collocation is reasonably feasible.

38 (d) The local government shall make a determination approving or denying an application  
39 under this section within 30 days after the completed application is received.

40 (e) The local government may condition approval of an application for a new advanced  
41 air mobility radar on any of the following:

42 (1) If not included in the completed application, the provision of a collocation  
43 agreement if collocation is deemed feasible.

44 (2) The permit applicant obtaining a Federal Communications Commission  
45 operator license for any spectrum band required for the installation.

46 (3) The installation of the advanced air mobility radar in a manner that complies  
47 with all applicable federal and State laws, and local development regulations.

48 (4) The operation of the advanced air mobility radar in a manner that complies  
49 with all safety guidelines issued by the Federal Communications Commission  
50 regarding limiting exposure to electromagnetic radiation.



1           (5)    The requirement to construct facilities within a reasonable period of time,  
2               which shall be no less than 24 months.

3    **"§ 160D-973. Collocation on local government property.**

4           (a)    Subject to Article 12 of Chapter 160A of the General Statutes, a local government  
5    may agree to collocation on property owned by the local government, subject to any existing  
6    easements or lease agreements. G.S. 160A-321 shall not apply to the lease of any city-owned  
7    water tower for collocation of advanced air mobility radar.

8           (b)    Within 30 days of receipt of a request for collocation, a local government shall either  
9    initiate lease or disposal of the collocation property or deny the request. A request for collocation  
10   under this section may be denied only for the following reasons:

11           (1)    There is insufficient capacity.

12           (2)    Reasons of safety, reliability, and generally applicable engineering principles,  
13    and those limitations cannot be remedied by rearranging, expanding, or  
14    otherwise reengineering the eligible facilities at the reasonable and actual cost  
15    of the local government to be reimbursed by the permit applicant.

16           (3)    The terms of property ownership prohibit collocation."

17    **SECTION 23.(b)** This section becomes effective October 1, 2024.

19    **REQUIRE TRANSPARENCY IN THE SALE OR RESALE OF TICKETS TO AN**  
20    **ENTERTAINMENT EVENT**

21           **SECTION 24.(a)** Article 1 of Chapter 75 of the General Statutes is amended by  
22    adding a new section to read:

23    **"§ 75-44. Ticket price transparency.**

24           (a)    As used in this section the following definitions apply:

25           (1)    Entertainment event. – A sporting game or contest, concert, or other  
26    entertainment performance with a live presentation element in this State for  
27    which attendance is available to the public through the purchase of ticket.

28           (2)    Mandatory fee. – Any fee or surcharge that a consumer must pay in order to  
29    purchase a ticket to an entertainment event.

30           (3)    Resale. – The second or subsequent sale of a ticket through a website or other  
31    electronic means.

32           (4)    Reseller. – A person engaged in the resale of tickets.

33           (5)    Secondary ticket exchange. – An electronic marketplace that enables persons  
34    to sell, purchase, and resell tickets.

35           (6)    Ticket issuer. – The person that is the first seller of tickets for an entertainment  
36    event, including a musician or musical group, an operator of a venue, sponsor  
37    or a promoter of an entertainment event, a sports team participating in an  
38    entertainment event, a sports league whose teams are participating in an  
39    entertainment event, a theater company, a marketplace or service operated for  
40    consumers to make an initial purchase of tickets, or an agent of any of the  
41    persons listed in this subdivision.

42           (7)    Ticketing session. – The period of time beginning when the price of a ticket  
43    to an entertainment event is first displayed to a person through a website or  
44    application and ending when the person has not purchased the ticket within  
45    the time period prescribed by the secondary ticket exchange, ticket issuer, or  
46    reseller.

47           (b)    A secondary ticket exchange, ticket issuer, or reseller shall meet the following  
48    requirements when listing a ticket for sale or resale:

49           (1)    At any time the price of the ticket is displayed to the purchaser, the listing  
50    shall clearly and conspicuously disclose the total price of the ticket, including  
51    all mandatory fees and the maximum order processing fee, if any.

- 1           (2)    The total price of the ticket initially displayed at the beginning of a ticketing  
2           session shall not be increased during that ticketing session, except by the  
3           addition of the charges permitted under subdivision (4) of this subsection.  
4           (3)    The listing shall clearly and conspicuously disclose to the consumer the  
5           existence and actual dollar amount of each mandatory fee, if any, prior to the  
6           completion of the transaction. The descriptor used to identify each mandatory  
7           fee shall not be deceptive or misleading.  
8           (4)    The following charges are not mandatory fees and may be added to the ticket  
9           price and shall be disclosed to the purchaser prior to purchase of the ticket:  
10          a.     Actual charges required to deliver a non-electronic ticket to the  
11             address specified by the purchaser by the delivery method designated  
12             by the purchaser.  
13          b.     Taxes or fees imposed on the transaction by any government.  
14          c.     A reasonable fee for processing the order.  
15          (c)    A violation of this section is an unfair trade practice under G.S. 75-1.1 and is subject  
16          to all of the investigative, enforcement, and penalty provisions of an unfair trade practice under  
17          this Article."

18           **SECTION 24.(b)** This section becomes effective January 1, 2025, and applies to  
19 tickets listed for sale or resale on or after that date.

21 **TECHNICAL CORRECTION TO SESSION LAW 2023-112 CONCERNING THE**  
22 **WINSTON-SALEM CIVIL REVIEW BOARD**

23           **SECTION 25.** Section 111.1(l) of the Charter of Winston-Salem, being Chapter 232  
24 of the Private Laws of 1927, as enacted by Chapter 112 of the 2023 Session Laws, reads as  
25 rewritten:

26           "(l) Any member of the classified service who desires a hearing shall file a request for  
27 hearing with the city clerk within ~~1,030 days~~ 10 days after learning of the action or omission of  
28 which the member complains, but not before the member has exhausted all remedies provided  
29 by the grievance procedures established by ordinance or policy of the city. The grievance  
30 procedure shall be concluded within 30 days. If the grievance procedure is not concluded within  
31 30 days, the member may proceed as provided in this subsection. Upon receipt of the request for  
32 hearing, the city clerk shall set the matter for hearing before the Board at a date not less than five  
33 nor more than 15 days from the clerk's receipt of the request. Except for the time for filing the  
34 initial request for hearing with the Board, the Board may extend the time for taking action for  
35 cause or by agreement of the parties to the proceeding. Any member of the classified service of  
36 the city who requests a hearing as authorized by this section shall be entitled to be represented at  
37 the hearing by his or her attorney. For purposes of the hearings, the Board is authorized to issue  
38 subpoenas for the attendance of witnesses or the production of documents."

43           **SECTION 26.** G.S. 153A-284 reads as rewritten:

44           "**§ 153A-284. Power to require connections.**

45           (a) A county may require the owner of developed property on which there are situated  
46 one or more residential dwelling units or commercial establishments located so as to be served  
47 by a water line or sewer collection line owned, leased as lessee, or operated by the county or on  
48 behalf of the county to connect the owner's premises with the water or sewer line and may fix  
49 charges for these connections. A county may only require connection of an owner's premises to  
50 a sewer line, however, if the county has adequate capacity to transport and treat the proposed  
51 new wastewater from the premises at the time of connection.

1       ...."

3       **COAL COMBUSTION RESIDUAL REPORT REVISION**

4               **SECTION 27.** G.S. 130A-309.204(a) reads as rewritten:

5               "(a) The Department shall submit ~~quarterly written reports~~ an annual report no later than  
6 October 1 to the Environmental Review Commission on its operations, activities, programs, and  
7 progress with respect to its obligations under this Part concerning all coal combustion residuals  
8 surface impoundments. This report may be combined with the report to members of the General  
9 Assembly required by subsection (b) of this section. At a minimum, the report shall include  
10 information concerning the status of assessment, corrective action, prioritization, and closure for  
11 each coal combustion residuals surface impoundment and information on costs connected  
12 therewith. The report shall include an executive summary of each annual Groundwater Protection  
13 and Restoration Report submitted to the Department by the operator of any coal combustion  
14 residuals surface impoundments pursuant to G.S. 130A-309.211(d) and a summary of all  
15 groundwater sampling, protection, and restoration activities related to the impoundment for the  
16 preceding year. The report shall also include an executive summary of each annual Surface Water  
17 Protection and Restoration Report submitted to the Department by the operator of any coal  
18 combustion residuals surface impoundments pursuant to G.S. 130A-309.212(e) and a summary  
19 of all surface water sampling, protection, and restoration activities related to the impoundment  
20 for the preceding year, including the status of the identification, assessment, and correction of  
21 unpermitted discharges from coal combustion residuals surface impoundments to the surface  
22 waters of the State. The Department shall supplement the written reports required by this  
23 subsection with additional written and oral reports as may be requested by the Environmental  
24 Review Commission. The Department shall submit the written reports required by this subsection  
25 whether or not the General Assembly is in session at the time the report is due."  
26

27       **REQUIRE THE DEPARTMENT OF ENVIRONMENTAL QUALITY TO REPORT**  
28 **QUARTERLY ON APPLICATIONS FOR PERMITS REQUIRED FOR NATURAL GAS**  
29 **PIPELINES AND GAS-FIRED ELECTRIC GENERATION FACILITIES**

30               **SECTION 28.(a)** Part 1 of Article 7 of Chapter 143B of the General Statutes is  
31 amended by adding a new section to read:

32       "**§ 143B-279.20. Report on Department activity to process applications for permits**  
33 **required for natural gas pipelines and gas-fired electric generation facilities.**

34               The Department of Environmental Quality shall report on any applications received for  
35 permits required for siting or operation of natural gas pipelines and gas-fired electric generation  
36 facilities within the State, and activities of the Department to process such applications, including  
37 tracking of processing times. The processing time tracked shall include (i) the total processing  
38 time from when an initial permit application is received to issuance or denial of the permit and  
39 (ii) the processing time from when a complete permit application is received to issuance or denial  
40 of the permit. The Department shall report quarterly to the Joint Legislative Commission on  
41 Energy Policy pursuant to this section."

42               **SECTION 28.(b)** This section is effective when it becomes law and applies to  
43 applications for permits for natural gas pipelines and gas-fired electric generation facilities  
44 pending on or received on or after that date. The Department shall submit the initial report due  
45 pursuant to G.S. 143B-279.20, as enacted by this section, no later than October 1, 2024.

49               **SECTION 29.** Section 12.14(j) of S.L. 2021-180 reads as rewritten:

50               "**SECTION 12.14.(j)** Report. – The Department shall submit a report no later than  
51 September 1, 2022, and annually thereafter no later than November 1 to the chairs of the Joint

1 Legislative Oversight Committee on Agriculture and Natural and Economic Resources  
2 Resources, the Environmental Review Commission, and the Fiscal Research Division on the  
3 projects and activities funded by this section until all funds have been expended by grant  
4 recipients. The reports required by this section shall be submitted with the reports required by  
5 G.S. 159G-26 and G.S. 159G-72 as a single report. The Department shall include in its initial  
6 report and may include in subsequent reports recommendations regarding legislative changes or  
7 additional funding needed to assist small and financially distressed communities to comply with

9 events on stormwater-related flood events. The reports shall also include, at a minimum, the

- 11 (1) The beginning and ending balance of the Fund for the fiscal year.
- 12 (2) A listing of grant recipients, amount provided to each recipient, and the grant  
13 type funded.
- 14 (3) An overview of the use of funds by grant recipients, including a description  
15 of projects constructed or planning milestones achieved."

19 **SECTION 30.(a)** G.S. 77-98 reads as rewritten:

21 The Commission shall submit an annual report, including the annual audit required by  
22 G.S. 77-96 and any recommendations, on or before 1 October of each year in which the  
23 Commission meets to the Joint Legislative Oversight Committee on Agriculture and Natural and  
24 Economic Resources, the Fiscal Research Division of the General Assembly of North Carolina,  
25 and as provided by the Commonwealth of Virginia."

26 **SECTION 30.(b)** G.S. 77-117 reads as rewritten:

#### 27 **"§ 77-117. Annual report.**

28 The commissions shall submit annual reports, including the annual audit required by  
29 G.S. 77-115 and any recommendations, on or before October 1 of each year in which the  
30 commissions meet to Joint Legislative Oversight Committee on Agriculture and Natural and  
31 Economic Resources, the Fiscal Research Division of the General Assembly of North Carolina,

42 **SECTION 33.(a)** If any provision of this act or the application thereof to any person  
43 or circumstances is held invalid, such invalidity shall not affect other provisions or applications  
44 of this act that can be given effect without the invalid provision or application and, to this end,  
45 the provisions of this act are declared to be severable.

46 **SECTION 33.(b)** Except as otherwise provided, this act is effective when it becomes  
47 law.
