A BILL TO BE ENTITLED
AN ACT TO AMEND THE REQUIREMENTS FOR CERTAIN AUTOMATICALLY
RENEWING CONSUMER CONTRACTS.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 75-41 reads as rewritten:

"§ 75-41. Contracts with automatic renewal clauses.

(a) Any person engaged in commerce that sells, leases, or offers to sell or lease, any products or services to a consumer pursuant to a contract ~~where the contract automatically renews unless the consumer cancels the contract,~~ that contains an automatic renewal provision for a term of more than one month shall do all of the following:

(1) ~~Disclose the automatic renewal clause clearly and conspicuously in the contract or contract offer.~~ Provide a disclosure statement that provides notice of all of the following clearly and conspicuously in at least 12-point type and in bold print:

- a. That the contract will be automatically renewed unless the consumer gives notice to the seller of the consumer's intention to terminate the contract prior to the renewal date. There shall be a space beside this disclosure to be initialed by the consumer acknowledging the consumer's specific consent to this provision of the contract.
- b. The length of the initial term of the contract and the length of each renewal period under the contract.
- c. The amount to be charged to the consumer for the initial term of the contract and the amount to be charged to the consumer for any renewal periods, if known.
- d. If any terms of the contract will change upon contract renewal, a list and explanation of those terms.
- e. An electronic mail address, mailing address, toll-free telephone number, or another cost-effective, timely, and easy-to-use mechanism that the consumer may use to terminate the automatic renewal. A consumer who enters into a contract online shall be permitted to cancel the contract online.

9 15 days but no earlier than ~~45-60~~ days before the date the contract is to be
10 automatically renewed, stating the date on which the contract is scheduled to
11 automatically renew and notifying the consumer that the contract will
12 automatically renew unless it is cancelled by the consumer prior to that date.
- 13 (4) ~~If the terms of the contract will change upon the automatic renewal of the~~

17 (d) ~~This section does not apply to insurers licensed under Chapter 58 of the General~~
18 ~~Statutes, or to banks, trust companies, savings and loan associations, savings banks, or credit~~
19 ~~unions licensed or organized under the laws of any state or the United States, or any foreign bank~~
20 ~~maintaining a branch or agency licensed under the laws of the United States, or any subsidiary~~
21 ~~or affiliate thereof, nor does this section apply to any entity subject to regulation by the Federal~~
22 ~~Communications Commission under Title 47 of the United States Code or by the North Carolina~~
23 ~~Utilities Commission under Chapter 62 of the General Statutes, or to any entity doing business~~

27 (f) For purposes of this section, the term "automatic renewal provision" means a
28 provision under which a contract is automatically renewed at the end of a definite term for a
29 subsequent term of more than one month. Such renewal is effective unless the consumer gives
30 notice to the seller of the consumer's intention to terminate the contract."

31 **SECTION 2.** This act becomes effective January 1, 2026, and applies to contracts
32 entered into on or after that date.
