- Administration of Local Food Tax. The Secretary must administer local sales and use taxes imposed on food as if they were imposed under this Article. This applies to local taxes on food imposed under Subchapter VIII of this Chapter and under Chapter 1096 of the 1967 Session Laws."
- **SECTION 2.** This act becomes effective October 1, 2025, and applies to sales made on or after that date.
