There is appropriated from the General Fund to the Office of State 5 6 Budget and Management the sum of fifteen million seven hundred sixty thousand dollars 7 (\$15,760,000) in nonrecurring funds for the 2025-2026 fiscal year to provide a directed grant to 8 Wayne County to be used as follows: 9 Five million dollars (\$5,000,000) for a capital project at Rosewood Middle (1) 10 Two million dollars (\$2,000,000) to update the athletic track at Dillard Middle 11 (2) 12 School. 13 One million dollars (\$1,000,000) for water and sewer upgrades for the Village (3) 14 of Walnut Creek. 15 Seven hundred fifty thousand dollars (\$750,000) for "Saving Union Station" (4) revitalization project. 16 Five hundred thousand dollars (\$500,000) for a training facility for the Wayne 17 (5) County Sheriff's Office. 18 19 One million dollars (\$1,000,000) for Wayne County United Way. (6) Two hundred fifty thousand dollars (\$250,000) for Wayne County Alcohol 20 (7) 21 Anonymous. 22 Two hundred fifty thousand dollars (\$250,000) for the Tuscarora Council (8) Scouting Program. 23 Five million dollars (\$5,000,000) for the Mattamuskeet Lodge Restoration 24 (11)25 Initiative. 26 Ten thousand dollars (\$10,000) for Pricetown Volunteer Fire Department.

SECTION 2. There is appropriated from the General Fund to the Administrative Office of the Courts the sum of one hundred sixty-two thousand three hundred fifty-one dollars (\$162,351) in recurring funds for each year of the 2025-2027 fiscal biennium and three thousand seven hundred fifty-two dollars (\$3,752) in nonrecurring funds in the 2025-2026 fiscal year to be used to hire one assistant district attorney for Prosecutorial District 9.

34 35 **SECTION 3.** There is appropriated from the General Fund to the Administrative Office of the Courts, Office of Indigent Defense Services, the sum of two million three hundred forty-seven thousand seventy-one dollars (\$2,347,071) in recurring funds for each year of the 2025-2027 fiscal biennium and ninety-six thousand seven hundred thirty dollars (\$96,730) in



- nonrecurring funds for the 2025-2026 fiscal year to create a new Defender District 9 serving Green County, Lenoir County, and Wayne County and to hire the following positions:
 - (1) One Chief Public Defender.
- 4 (2) Ten Assistant Public Defenders.
 - (3) Two Chief Investigators.
- 6 (4) One Social Worker.
